

**AMENDMENT TO RULES COMMITTEE PRINT OF  
H.R. 7  
OFFERED BY MR. FLAKE OF ARIZONA**

Beginning on page 12, strike line 6 and all that follows through page 13, line 13.

Page 25, strike lines 1 through 21 (and redesignate any subsequent sections accordingly).

Page 26, strike lines 14 through 18.

Beginning on page 45, strike line 3 and all that follows through page 46, line 3.

Page 55, beginning on line 23, strike “, including” and all that follows through “System”.

Page 64, strike lines 17 and 18 (and redesignate any subsequent subparagraphs accordingly).

Page 64, strike lines 21 through 23.

Page 93, strike line 10 and all that follows through page 94, line 6 (and conform the table of contents accordingly).

Strike title II of the Rules Committee Print (and redesignate any subsequent titles accordingly and conform the table of contents).

Page 911, strike line 1 and all that follows through line 23 on page 912 and insert the following:

**1 SEC. 15004. MASS TRANSIT ACCOUNT.**

2 (a) REPEAL OF MASS TRANSIT ACCOUNT.—Section  
3 9503 of the Internal Revenue Code of 1986 is amended  
4 by striking subsection (e).

5 (b) TRANSFER OF HIGHWAY ACCOUNT OF 2012 AP-  
6 PROPRIATED AMOUNTS BASED ON FUELS TAX RE-  
7 CEIPTS.—Amounts transferred on or before the date of  
8 the enactment of this section to the Mass Transit Account  
9 in the Highway Trust Fund for fiscal year 2012 are here-  
10 by transferred to the Highway Account of the Highway  
11 Trust Fund (as defined in section 9503(e)(5)(B) of the  
12 Internal Revenue Code of 1986, as in effect on the day  
13 before the date of the enactment of this Act).

14 (c) EFFECTIVE DATE.—The amendment made by  
15 subsection (a) shall take effect on the date of the enact-  
16 ment of this Act.

Page 912, after line 23, insert the following:

1 **SEC. 15006. NO REVENUES, NO SPENDING.**

2 (a) OMB CALCULATIONS.—Not later than 60 days  
3 after the date of the enactment of this Act, the Director  
4 of the Office of Management and Budget shall determine  
5 the difference between the spending authorized by this Act  
6 and the amendments made by this bill and the revenues  
7 available in the Highway Trust Fund.

8 (b) SPENDING REVENUE IMBALANCE.—If the Direc-  
9 tor determines that amount available in the Highway  
10 Trust Fund on such date is less than the amount author-  
11 ized by this Act and the amendments made by this Act—

12 (1) no additional funds are authorized to be  
13 spent; and

14 (2) the Secretary shall reduce proportionately  
15 the amount of sums authorized to be appropriated  
16 from the Highway Trust Fund for programs under  
17 this Act and to programs amended by this Act.

Page 913, strike line 1 and all that follows through  
line 21 on page 925.
