

**AMENDMENT TO THE RULES COMMITTEE PRINT
FOR H.R. 3080
OFFERED BY MS. HAHN OF CALIFORNIA**

At the end of title II, insert the following:

1 **SEC. 2 ___. USE OF HARBOR MAINTENANCE TRUST FUND**
2 **TO SUPPORT PORT DREDGING.**

3 (a) AVAILABILITY OF AMOUNTS.—Section 210 of the
4 Water Resources Development Act of 1986 (33 U.S.C.
5 2238) is amended—

6 (1) in the section heading by striking “**AU-**
7 **THORIZATION OF APPROPRIATIONS**” and insert-
8 ing “**FUNDING FOR PORT DREDGING**”; and

9 (2) in subsection (a) by striking “are author-
10 ized to be appropriated” and inserting “shall be
11 available, without further appropriation,”.

12 (b) AMENDMENT TO TRUST FUND CODE.—Section
13 9505(c) of the Internal Revenue Code of 1986 is amend-
14 ed—

15 (1) in the matter preceding paragraph (1) by
16 striking “shall be available, as provided by appro-
17 priations Acts,” and inserting “shall be available,
18 without further appropriation,”; and

1 (2) in paragraph (1) by striking “Water Re-
2 sources Development Act of 1996” and inserting
3 “Water Resources Reform and Development Act of
4 2013”.

5 **SEC. 2 ____ . BUDGETARY TREATMENT OF HARBOR MAINTENANCE TRUST FUND.**

7 (a) RECEIPTS AND ADJUSTMENTS.—Notwith-
8 standing any other provision of law, the receipts and dis-
9 bursements of the Harbor Maintenance Trust Fund—

10 (1) shall not be counted as new budget author-
11 ity, outlays, receipts, or deficit or surplus for pur-
12 poses of—

13 (A) the budget of the United States Gov-
14 ernment as submitted by the President;

15 (B) the congressional budget (including al-
16 locations of budget authority and outlays pro-
17 vided therein);

18 (C) the Balanced Budget and Emergency
19 Deficit Control Act of 1985; or

20 (D) the Statutory Pay-As-You-Go Act of
21 2010;

22 (2) shall be exempt from any general budget
23 limitation imposed by statute on expenditures and
24 net lending (budget outlays) of the United States
25 Government; and

1 (3) shall be available only for the purposes
2 specified in section 9505(c) of the Internal Revenue
3 Code of 1986.

4 (b) ADDITION TO APPROPRIATIONS.—Any amounts
5 made available from disbursements of the Harbor Mainte-
6 nance Trust Fund to the Army Corps of Engineers shall
7 not be considered to be an addition to the appropriation
8 made available to such Corps.
