Page 2, line 15, through page 3, line 21, insert “(reduced by \$12,000,000)” after the first dollar amount and “not more than” before the second dollar amount.

Page 4, line 16, after the dollar amount, insert “(reduced by \$5,000,000)”.

Page 5, line 6, after the dollar amount, insert “(reduced by \$556,000,000)”.

Page 5, line 21, after the dollar amount, insert “(reduced by \$495,000,000)”.

Page 6, line 13, after the dollar amount, insert “(reduced by \$2,000,000)”.
