Amendment to Rules Comm. Print 114–51 Offered by Mr. Pompeo of Kansas

At the end of subtitle E of title XII, add the following:

1SEC. 12xx. DEPARTMENT OF DEFENSE REPORT ON CO-2OPERATION BETWEEN IRAN AND THE RUS-3SIAN FEDERATION.

4 (a) REPORT REQUIRED.—The Secretary of Defense
5 shall submit to Congress a report on cooperation between
6 Iran and the Russian Federation and how and to what
7 extent such cooperation affects United States national se8 curity and strategic interests.

9 (b) MATTERS TO BE INCLUDED.—The report re-10 quired by subsection (a) shall include the following:

(1) How and to what extent Iran and the Russian Federation cooperate on matters relating to
Iran's space program, including how and to what extent such cooperation strengthens Iran's ballistic
missile program.

16 (2) How and to what extent Iran's interests
17 and actions and the Russian Federation's interests
18 and actions overlap with respect to Latin America.

1	(3) A description and analysis of the intel-
2	ligence-sharing center established by Iran, the Rus-
3	sian Federation, and Syria in Baghdad, Iraq and
4	whether such center is being used for purposes other
5	than the purposes of the joint mission of such coun-
6	tries in Syria.
7	(4) A description and analysis of—
8	(A) naval cooperation between Iran and
9	the Russian Federation, including joint naval
10	exercises between the two countries; and
11	(B) the long-term consequences of—
12	(i) a robust Russian Federation naval
13	presence in the Eastern Mediterranean;
14	and
15	(ii) an Iranian naval presence in the
16	Persian Gulf.
17	(5) How cooperation between Iran and the Rus-
18	sian Federation has increased with respect to the
19	Joint Comprehensive Plan of Action.
20	(6) The likelihood that Iran might adopt the
21	Russian Federation model of hybrid warfare against
22	potential targets such as Gulf Cooperation Council
23	states with sizeable Shiite populations.
24	(7) The extent of Russian Federation coopera-
25	tion with Hezbollah in Syria, Lebanon, and Iraq, in-

cluding cooperation with respect to training and
 equipping and joint operations.

3 (8) A full and explicit list of weapons that if
4 sold by the Russian Federation to Iran would violate
5 relevant United Nations Security Council resolutions
6 imposing an arms embargo on Iran.

7 (c) SUBMISSION PERIOD.—The report required by
8 subsection (a) shall be submitted not later than 120 days
9 after the date of the enactment of this Act, and annually
10 thereafter, for such period of time as the Joint Com11 prehensive Plan of Act remains in effect.

12 (d) FORM.—The report required by subsection (a)
13 shall be submitted in unclassified form, but may contain
14 a classified annex.
