

AMENDMENT TO H.R. 2017, AS REPORTED
(HOMELAND SECURITY APPROPRIATIONS)
OFFERED BY MR. PRICE OF NORTH CAROLINA

Page 45, line 18, after the dollar amount, insert “(increased by \$850,000,000)”.

Page 45, lines 19 and 20, strike “at the discretion of the Secretary of Homeland Security based on the following authorities” and insert “as follows”.

Page 45, line 21, through the end of the third proviso on page 47, line 24, strike all and insert the following:

1 (1) \$725,000,000 shall be for the State Home-
2 land Security Grant Program under section 2004 of
3 the Homeland Security Act of 2002 (6 U.S.C. 605),
4 of which \$55,000,000 shall be for Operation
5 Stonegarden and \$35,000,000 shall be for the Met-
6 ropolitan Medical Response System: Provided, That
7 subsection (c)(4) of such section 2004 shall not
8 apply to funds provided under this paragraph.

9 (2) \$725,000,000 shall be for the Urban Area
10 Security Initiative under section 2003 of the Home-
11 land Security Act of 2002 (6 U.S.C. 604), of which,

1 notwithstanding subsection (c)(1) of such section,
2 \$19,000,000 shall be for grants to organizations (as
3 described in subsection (c)(3) of section 501 of the
4 Internal Revenue Code of 1986 and exempt from
5 taxation under subsection (a) of such section) that
6 are determined by the Secretary to be at high risk
7 of a terrorist attack.

8 (3) \$200,000,000 shall be for public transpor-
9 tation security assistance and railroad security as-
10 sistance under sections 1406 and 1513 of the Imple-
11 menting Recommendations of the 9/11 Commission
12 Act of 2007 (6 U.S.C. 1135, 1163), of which
13 \$20,000,000 shall be for Amtrak security and
14 \$5,000,000 shall be for over-the-road bus security.

15 (4) \$200,000,000 shall be for port security
16 grants in accordance with section 70107 of title 46,
17 United States Code.

Page 47, line 24, strike “ *Provided further*” and in-
sert “ *Provided*”.

Page 47, line 25, strike “10 percent” and insert “5
percent”.

Page 48, line 20, strike “through (4)” and insert
“and (2)”.

Page 49, lines 2 and 3, strike “(5) through (9)” and insert “(3) and (4)”.

Page 53, line 6, insert before the colon the following:

1 , of which \$850,000,000 is designated as an emergency
2 pursuant to section 3(c)(1) of H. Res. 5 (112th Congress)
3 and as an emergency requirement pursuant to section
4 403(a) of S. Con. Res. 13 (111th Congress), the concur-
