

**AMENDMENT TO RULES COMMITTEE PRINT 115-**

**OFFERED BY MS. TENNEY OF NEW YORK**

Add at the end the following new section:

1 **SEC. 10. ANNUAL REPORT ON PERFORMANCE AWARDS AND**  
2 **BONUSES AWARDED TO CERTAIN HIGH-**  
3 **LEVEL EMPLOYEES OF THE DEPARTMENT OF**  
4 **VETERANS AFFAIRS.**

5 (a) IN GENERAL.—Chapter 7 of title 38, United  
6 States Code, is further amended by inserting after section  
7 723, as added by section 5, the following new section:

8 **“§ 724. Annual report on performance awards and bo-**  
9 **nuses awarded to certain high-level em-**  
10 **ployees**

11 “(a) IN GENERAL.—Not later than 30 days after the  
12 end of each fiscal year, the Secretary shall submit to the  
13 appropriate committees of Congress a report that con-  
14 tains, for the most recent fiscal year ending before the  
15 submittal of the report, a description of the performance  
16 awards and bonuses awarded to Regional Office Directors  
17 of the Department, Directors of Medical Centers of the  
18 Department, Directors of Veterans Integrated Service

1 Networks, and any other individual employed in a senior  
2 executive position.

3 “(b) ELEMENTS.—Each report submitted under sub-  
4 section (a) shall include the following with respect to each  
5 performance award or bonus awarded to an individual de-  
6 scribed in such subsection:

7 “(1) The amount of each award or bonus.

8 “(2) The job title of the individual awarded the  
9 award or bonus.

10 “(3) The location where the individual awarded  
11 the award or bonus works.

12 “(c) DEFINITIONS.—In this section:

13 “(1) The term ‘appropriate committees of Con-  
14 gress’ means—

15 “(A) the Committee on Veterans’ Affairs  
16 and the Committee on Appropriations of the  
17 Senate; and

18 “(B) the Committee on Veterans’ Affairs  
19 and the Committee on Appropriations of the  
20 House of Representatives.

21 “(2) The term ‘individual’ means—

22 “(A) a career appointee (as that term is  
23 defined in section 3132(a)(4) of title 5); or

24 “(B) any individual who occupies an ad-  
25 ministrative or executive position and who was

1 appointed under section 7306(a) or section  
2 7401(1) of this title.

3 “(3) The term ‘senior executive position’  
4 means—

5 “(A) with respect to a career appointee (as  
6 that term is defined in section 3132(a)(4) of  
7 title 5), a Senior Executive Service position (as  
8 such term is defined in section 3132(a)(2) of  
9 title 5); and

10 “(B) with respect to an individual ap-  
11 pointed under section 7306(a) or section  
12 7401(1) of this title, an administrative or exec-  
13 utive position.”.

14 (b) CLERICAL AMENDMENT.—The table of sections  
15 at the beginning of chapter 7 of such title is amended by  
16 inserting after the item relating to section 723, as added  
17 by section 5, the following new item:

“724. Annual report on performance awards and bonuses awarded to certain  
high-level employees.”.
