

AMENDMENT TO RULES COMMITTEE
PRINT 117-13
OFFERED BY MR. MALINOWSKI OF NEW JERSEY

At the end of title LX of division E, insert the following:

1 **SEC. 6013. PROHIBITION ON CERTAIN SALES BY MEMBERS**
2 **OR SPONSORS OF THE 2022 WINTER OLYM-**
3 **PICS.**

4 (a) SALES PROHIBITION.—Effective 90 days after
5 the conclusion of the 2022 Olympic and Paralympic Win-
6 ter Games, a person may not sell any product, made by
7 such person, on a military installation if—

8 (1) such person is a member or sponsor of—

9 (A) the Olympic Partner Programme of
10 the International Olympic Committee; or

11 (B) the Beijing Organising Committee for
12 the 2022 Olympic and Paralympic Winter
13 Games; and

14 (2) such person sends a representative, includ-
15 ing an executive or officer, to attend any portion of
16 the 2022 Olympic and Paralympic Winter Games in
17 the People’s Republic of China.

18 (b) RULEMAKING.—

1 (1) IN GENERAL.—Not later than 30 days after
2 the date of the enactment of this section, the Sec-
3 retary of Defense shall issue rules that—

4 (A) provide a means of verifying that a
5 person meets the criteria described in sub-
6 section (a);

7 (B) upon verification, provide a means of
8 notifying each such person that they are subject
9 to the sales prohibition under subsection (a);
10 and

11 (C) provide each such person 30 days after
12 the conclusion of the 2022 Olympic and
13 Paralympic Winter Games to respond to the
14 Secretary.

15 (2) FAILURE TO RESPOND.—A person notified
16 under paragraph (1)(B) that fails to respond pursu-
17 ant to paragraph (1)(C) shall be considered to be
18 subject to the sales prohibition under subsection (a).

19 (c) DEFINITIONS.—In this section:

20 (1) MILITARY INSTALLATION.—The term “mili-
21 tary installation” has the meaning given such term
22 in section 2801 of title 10, United States Code.

23 (2) PERSON.—The term “person” means—

24 (A) a natural person, corporation, com-
25 pany, business association, partnership, society,

1 trust, or any other nongovernmental entity, or-
2 ganization, or group;

3 (B) any governmental entity or instrumen-
4 tality of a government, including a multilateral
5 development institution (as defined in section
6 1701(c)(3) of the International Financial Insti-
7 tutions Act (22 U.S.C. 262r(c)(3))); and

8 (C) any successor, subunit, parent entity,
9 or subsidiary of, or any entity under common
10 ownership or control with, any entity described
11 in subparagraph (A) or (B).

12 (d) TERMINATION.—This section and the require-
13 ments of this section shall terminate on—

14 (1) the date on which a determination is made
15 that the 2022 Olympic and Paralympic Winter
16 Games will not be held in the People’s Republic of
17 China; or

18 (2) September 30, 2025.
