

**AMENDMENT TO RULES COMMITTEE PRINT 117-**

**54**

**OFFERED BY MR. JACKSON OF TEXAS**

At the end of subtitle F of title X, insert the following:

1 **SEC. 10\_\_\_. FIVE-YEAR PLAN FOR ASSISTANCE TO ISRAEL**  
2 **IN DEFENSE AGAINST EXISTENTIAL TER-**  
3 **RORIST THREATS.**

4 (a) **PLAN REQUIRED.**—Not later than 180 days after  
5 the date of the enactment of this Act, the Secretary of  
6 Defense shall submit to the congressional defense commit-  
7 tees a five-year plan under which the United States will  
8 provide Israel with the most effective assistance to defend  
9 itself from existential terrorist threats. Such plan shall in-  
10 clude each of the following:

11 (1) An assessment of the military capabilities  
12 Israel requires to defend against an attack by Iran  
13 or a military proxy of Iran, including an assessment  
14 of—

15 (A) arms and weapons;

16 (B) training operations;

17 (C) joint exercise opportunities;

18 (D) increases in intelligence sharing; and

1 (E) improved collaboration on  
2 cyberdefense.

3 (2) A strategy for United States assistance for  
4 Israel for defense against Iranian-funded terrorist  
5 proxies, including Hamas, Lebanese Hezbollah, Pal-  
6 estinian Islamic Jihad, Popular Front for the Lib-  
7 eration of Palestine, Asa'ib ahl al-Haq, Harakat  
8 Hezbollah al-Nujaba, Kata'ib Sayyid al Shuhada,  
9 Kata'ib al-Imam Ali, and Kata'ib Hezbollah.

10 (3) A proposed method by which Israel can ef-  
11 fectively defend its territory from Iranian or Iran-  
12 supplied rockets, drones, ballistic missiles, or other  
13 explosive devices.

14 (4) The certification of the Secretary of De-  
15 fense that such plan, if implemented, would provide  
16 all necessary support to allow Israel to defend itself  
17 from any existential threat.

18 (5) Such other elements as the Secretary deter-  
19 mines appropriate.

20 (b) FORM OF PLAN.—The plan required under sub-  
21 section (a) shall be submitted in unclassified form, but  
22 may include a classified annex.

23 (c) BRIEFING.—Not later than 30 days after the date  
24 of the submittal of the plan required under subsection (a),

1 the Secretary shall provide to the congressional defense  
2 committees a briefing on the plan.

3 (d) IMPLEMENTATION.—Not later 90 days after the  
4 date of the submittal of the plan required under subsection  
5 (a), the Secretary shall begin the implementation of the  
6 plan.
