

AMENDMENT TO H.R. 6800
OFFERED BY MR. RODNEY DAVIS OF ILLINOIS

Add at the end of division P the following new section:

1 **SEC. 160013. LIMIT ON NUMBER OF BALLOTS COLLECTED**
2 **BY CERTAIN THIRD PARTIES.**

3 (a) ESTABLISHING LIMIT.—Subtitle C of title III of
4 the Help America Vote Act of 2002, as added by section
5 160003(a) and as amended by sections 160004(a),
6 160005(a), and 160007(c)(1), is further amended—

7 (1) by redesignating sections 328 and 329 as
8 sections 329 and 330; and

9 (2) by inserting after section 327 the following
10 new section:

11 **“SEC. 328. LIMIT ON NUMBER OF BALLOTS COLLECTED BY**
12 **CERTAIN THIRD PARTIES.**

13 “(a) LIMIT.—An individual may collect and transmit
14 to an election official a ballot in an election for Federal
15 office that was mailed to another person, so long as the
16 number of ballots the individual collects and transmits
17 with respect to any election does not exceed 10.

1 “(b) EXCEPTION FOR CERTAIN INDIVIDUALS.—Sub-
2 section (a) does not apply with respect to any of the fol-
3 lowing:

4 “(1) An election official while engaged in offi-
5 cial duties as authorized by law.

6 “(2) An employee of the United States Postal
7 Service while engaged in official duties as authorized
8 by law.

9 “(3) Any other individual who is allowed by law
10 to collect and transmit United States mail, while en-
11 gaged in official duties as authorized by law.

12 “(4) A family member, household member, or
13 caregiver of the person to whom the ballot was
14 mailed.

15 “(c) DEFINITIONS.—For purposes of this section,
16 with respect to a person to whom the ballot was mailed:

17 “(1) The term ‘caregiver’ means an individual
18 who provides medical or health care assistance to
19 such person in a residence, nursing care institution,
20 hospice facility, assisted living center, assisted living
21 facility, assisted living home, residential care institu-
22 tion, adult day health care facility, or adult foster
23 care home.

1 “(2) The term ‘family member’ means an indi-
2 vidual who is related to such person by blood, mar-
3 riage, adoption or legal guardianship.

4 “(3) The term ‘household member’ means an
5 individual who resides at the same residence as such
6 person.”.

7 (b) CLERICAL AMENDMENT.—The table of contents
8 of such Act, as added by section 160003 and as amended
9 by sections 160004, 160005, and 16007, is further
10 amended—

11 (1) by redesignating the items relating to sec-
12 tions 328 and 329 as relating to sections 329 and
13 330; and

14 (2) by inserting after the item relating to sec-
15 tion 327 the following new item:

 “Sec. 328. Limit on number of ballots collected by certain third parties.”.

16 (c) EFFECTIVE DATE.—The amendments made by
17 this section shall apply with respect to the regularly sched-
18 uled general election for Federal office held in November
19 2020 and each succeeding election for Federal office.
