AMENDMENT TO RULES COMM. PRINT 117–54 OFFERED BY MR. MALINOWSKI OF NEW JERSEY

At the end of subtitle B of title XIII, add the following:

1 SEC. 13 . CEASEFIRE PROTECTION MEASURES.

2	(a) Support for Diplomacy on Ceasefire.—It is
3	the sense of Congress that the President and all relevant
4	agencies should use funds and resources at their disposal
5	to continue to engage in formal or informal diplomacy or
6	consultations with forces aligned with and under the con-
7	trol of the internationally recognized government, Ansar
8	Allah, the Saudi- and Emirati-led coalition, and any other
9	armed group, and United States in order to—
10	(1) continue to maintain any ceasefire or ces-
11	sation of hostilities in the war in Yemen; and
12	(2) create, conduct, or continue to facilitate a
13	legitimate peace process to end the war in Yemen.
14	(b) Verification Report.—Not later than 30 days
15	after the date of the enactment of this Act, and every 30
16	days thereafter for one year, the Secretary of State, in
17	coordination with the Director of National Intelligence,
18	Secretary of Defense, other relevant agencies, shall submit

19 to Congress a report that includes the following:

1	(1) An assessment on the current status of any
2	ceasefire or cessation of hostilities between the
3	forces aligned with and under the control of the
4	internationally recognized government, Ansar Allah,
5	the Saudi- and Emirati-led coalition, and any other
6	armed group.
7	(2) A list of any violations of any existing
8	ceasefire or cessation of hostilities in Yemen by—
9	(A) armed forces aligned with and under
10	the control of—
11	(i) the internationally recognized gov-
12	ernment of Yemen;
13	(ii) Ansar Allah; and
14	(iii) any other armed group included
15	in any ceasefire;
16	(B) airstrikes or drone strikes conducted
17	by—
18	(i) the Saudi Royal Air Force; or
19	(ii) the United Arab Emirates Air
20	Force and Air Defense.
21	(3) An assessment of how many fuel shipments,
22	including how many tons of fuel, have entered the
23	port of Hodeida since April 2, 2022, and whether
24	the collection of custom duties at the port of

1	Hodeida are used to pay the salaries of public sector
2	employees.
3	(4) A description of the reopening of the Sanaa
4	International Airport to commercial flights, includ-
5	ing how many flights have arrived and departed the
6	airport since April 2, 2022.
7	(5) An assessment of road access to and from
8	the city of Taiz, including the estimated time of
9	travel between Taiz and the city of Aden and any
10	other measurements used to determine the freedom
11	of movement to and from Taiz.
12	(6) A list and assessment of any additional con-
13	ditions or measures included after the date of enact-
14	ment of this Act in any ceasefire, peace process, or
15	negotiated peace settlement in Yemen.
16	(7) An assessment and description of the ad-
17	ministration's diplomatic strategy and efforts to
18	maintain any ceasefire and build on it to advance a
19	negotiated, legitimate, and permanent peace settle-
20	ment to end the war.
21	(8) An analysis of the barriers to progress on
22	elements of the truce and ways to incentivize
23	progress towards maintain the truce and building a
24	more sustainable political resolution to the conflict.

1 (c) Support for Multilateral Human Rights INVESTIGATIVE MECHANISM.—Not later than 60 days 3 after the date of the enactment of this Act, the Secretary 4 of State shall provide a briefing to the appropriate committees on the benefits and utility of providing direct support to an independent multilateral investigative mechanism to document and report past, ongoing, and future 8 violations of human rights and international humanitarian law by all parties in the conflict since 2015. 10 (d) Ceasfire Mainteinance Mechanisms; Prohi-BITION OF LICENSES AUTHORIZING EXPORTS OF CER-12 TAIN DEFENSE SERVICES.—For a 2-year period pursuant to the latest violations listed in subsection (b)(2)(B), the President may not issue any license, and shall suspend any 14 15 license or other approval that was issued before such date of the enactment of this Act authorizing the export to the 16 Government of Saudi Arabia or the Government of UAE 18 of defense services related to the maintenance or servicing 19 of United States-provided aircraft belonging to military units determined to have undertaken offensive airstrikes 20 21 inside Yemen after the date of enactment of this Act that 22 are not related directly to preventing or degrading the 23 ability of Ansar Allah forces to launch missile and unmanned aircraft strikes on the territory of Saudi Arabia

or the United Arab Emirates.

- 2 shall be submitted in unclassified form, but may contain
- 3 a classified annex so long as it is provided separately from
- 4 the unclassified version.
