At the appropriate place in subtitle F of title VIII,
insert the following:

1 **SEC. 8___ . STANDARDIZE SMALL BUSINESS PROCUREMENT**

2 **GOAL REPORTING.**

3 Section 15(h) of the Small Business Act (15 U.S.C.
4 644(h))—

5 (1) in paragraph (1)—

6 (A) in subparagraph (A), by inserting after
7 “during such fiscal year” the following: “and
8 the two fiscal years immediately preceding such
9 fiscal year, including—

10 “(i) the percentage awarded to each
11 such category of small business concern of
12 the total value of procurement contracts
13 awarded to such small business concerns;

14 “(ii) the total value of procurement
15 contracts awarded to such small business
16 concerns;

17 “(iii) the number of small business
18 concerns in each such category of small

1 business concern that awarded a procure-
2 ment contract by the Federal agency; and

3 “(iv) the number of such small busi-
4 ness concerns awarded a procurement con-
5 tract by the Federal agency for the first
6 time;”;

7 (B) in subparagraph (C), by striking
8 “and”;

9 (C) by redesignating subparagraph (D) as
10 subparagraph (E);

11 (D) by inserting after subparagraph (C)
12 the following new subparagraph:

13 “(D) a list of the proposed practices in-
14 cluded in the remediation submitted in previous
15 report submitted under this paragraph, includ-
16 ing a discussion of the actions taken to imple-
17 ment each such proposed practice and an anal-
18 ysis of the efficacy of each proposed practice in
19 helping the agency to meet such goals;”;

20 (E) in subparagraph (E), as so redesign-
21 ated, by striking the period at the end and in-
22 serting “; and”; and

23 (F) by adding at the end the following new
24 subparagraph:

1 “(F) any examples of practices imple-
2 mented pursuant to a remediation plan under
3 subparagraph (E) that increased the participa-
4 tion of small business concerns in categories for
5 which the agency has historically not met such
6 goals.”; and

7 (2) in paragraph (2)—

8 (A) in subparagraph (D), by striking
9 “and” at the end;

10 (B) by redesignating subparagraphs (E)
11 and (F) as subparagraphs (F) and (G), respec-
12 tively; and

13 (C) by inserting after subparagraph (D)
14 the following new subparagraph:

15 “(E) a list of the practices submitted to
16 the Administrator under paragraph (1)(F) and
17 any other practices from Federal agencies that
18 the Administrator determines to effectively help
19 Federal agencies meet such goals; and”.
