

AMENDMENT TO RULES COMM. PRINT 119-8
OFFERED BY MR. MCDOWELL OF NORTH
CAROLINA

At the end of subtitle B of title XVII, add the following:

1 **SEC. 17___. REPORT ON ENTITIES COLLABORATING WITH**
2 **XINJIANG PRODUCTION AND CONSTRUCTION**
3 **CORPS (XPCC).**

4 (a) **IN GENERAL.**—Not later than 180 days after the
5 date of the enactment of this Act, the Secretary of State,
6 in consultation with the Secretary of Defense and the Di-
7 rector of National Intelligence, shall submit to the appro-
8 priate congressional committees a report on entities col-
9 laborating with the Xinjiang Production and Construction
10 Corps (XPCC).

11 (b) **ELEMENTS.**—The report required in subsection
12 (a) shall include the following:

13 (1) A list each foreign person that—

14 (A) engages, or in the past five years has
15 engaged, in transactions with XPCC or any en-
16 tity currently under United States sanctions for
17 violations of the Uyghur Human Rights Policy
18 Act of 2020 (Public Law 116–145) or Public

1 Law 117–78 (commonly referred to as the
2 “Uyghur Forced Labor Prevention Act”);

3 (B) uses, in whole or in part, in any good
4 which such person produces or sells, a good or
5 material produced by XPCC or any entity cur-
6 rently under United States sanctions for viola-
7 tions of either of such Acts; or

8 (C) provides material, technological, or fi-
9 nancial support to XPCC or any entity cur-
10 rently under United States sanctions for viola-
11 tions of either of such Acts.

12 (2) A description of the activities in which the
13 foreign person described in paragraph (1) has en-
14 gaged to justify the inclusion of such person on the
15 list required under such paragraph.

16 (c) CLASSIFICATION.—

17 (1) LIST.—The list required under paragraph
18 (1) of subsection (b) shall be submitted in unclassi-
19 fied form.

20 (2) ACTIVITIES.—The description of the activi-
21 ties required under paragraph (2) of subsection (b)
22 shall be submitted in unclassified form but may con-
23 tain a classified annex.

24 (d) DEFINITIONS.—In this section:

1 (1) Appropriate congressional committees—The
2 term “appropriate congressional committees” means
3 the following:

4 (A) The congressional defense committees.

5 (B) The Committee on Foreign Affairs and
6 Permanent Select Committee on Intelligence of
7 the House of Representatives.

8 (C) The Committee on Foreign Relations
9 and the Select Committee on Intelligence of the
10 Senate.

11 (2) XPCC.—The term “XPCC” means the
12 Xinjiang Production and Construction Corps and
13 any subsidiary, affiliate, or successor entity of the
14 Xinjiang Production and Construction Corps.
