At the end of subtitle E of title V, add the following new section:

1 SEC. 5____. COPYRIGHT PROTECTION FOR CIVILIAN FAC 2 ULTY OF ACCREDITED INSTITUTIONS.

3 (a) IN GENERAL.—Chapter 108 of title 10, United
4 States Code, is amended by adding at the end the fol5 lowing new section:

6 "§2169a. Copyright of works created by civilian fac7 ulty members

8 "(a) COPYRIGHT OF WORKS.—Subject to subsection 9 (b), for purposes of sections 101 and 105 of title 17, a work produced by a civilian member of the faculty of a 10 11 covered institution is only a work of the United States Government if the work is created in direct support of a 12 lecture, instruction, curriculum development, or special 13 duty assigned to such civilian member at the covered insti-14 15 tution.

16 "(b) USE BY FEDERAL GOVERNMENT.—The Sec17 retary concerned may require a civilian member of the fac18 ulty of a covered institution who becomes the owner of

a copyright in a work that would be considered a work
 of the United States Government but for the applicability
 of subsection (a) to—

- 4 "(1) provide the Federal Government with an
 5 irrevocable, royalty-free, world-wide, nonexclusive li6 cense to use, modify, reproduce, release, perform,
 7 display, or disclose such work for United States Gov8 ernment purposes; and
- 9 "(2) authorize the Federal Government to au10 thorize persons that are not officers or employees of
 11 the Federal Government to use, modify, reproduce,
 12 release, perform, display, or disclose such work for
 13 United States Government purposes.
- 14 "(c) COVERED INSTITUTION DEFINED.—In this sec-15 tion, the term 'covered institution' means the following:
- 16 "(1) National Defense University.
- 17 "(2) United States Military Academy.
- 18 "(3) Army War College.
- 19 "(4) United States Army Command and Gen-20 eral Staff College.
- 21 "(5) United States Naval Academy.
- 22 "(6) Naval War College.
- 23 "(7) Naval Post Graduate School.
- 24 "(8) Marine Corps University.
- 25 "(9) United States Air Force Academy.
