6	"(b) Expiration of Charter.—If the corporation
7	does not comply with the provisions of this chapter, the
8	charter granted by subsection (a) expires.
9	"§ 230202. Purposes
10	"The purposes of the corporation are those provided
11	in its articles of incorporation and include the following:
12	"(1) To organize as a veterans service organiza-
13	tion to maintain a continuing interest in the welfare
14	of veterans by—
15	"(A) advocating for, and increasing sus-
16	tainable homeownership;
17	"(B) providing financial literacy education,
18	"(C) spreading awareness of housing loans
19	guaranteed by the Secretary of Veterans Af-
20	fairs; and
21	"(D) increasing economic opportunities for
22	members of the Armed Forces and veterans.
23	"(2) To establish facilities for the assistance of
24	all veterans, with programs regarding topics includ-
25	ing the following:

1	"(A) financial literacy (including under-
2	standing credit);
3	"(B) workforce development;
4	"(C) small business incubation and
5	mentorship;
6	"(D) education regarding housing, includ-
7	ing homelessness prevention, rental counseling,
8	foreclosure prevention, and affordable housing
9	opportunities; and
10	"(E) suicide awareness and prevention.
11	"(3) To provide a forum for real estate and fi-
12	nancial service professionals to share ideas, learn,
13	and be empowered to better serve the real estate
14	needs of members of the Armed Forces, veterans,
15	their families, and others.
16	"(4) To collaborate with organizations in the
17	real estate & financial service sector to support em-
18	ployment of, and economic and business development
19	for, veterans.
20	"§ 230203. Membership
21	"Eligibility for membership in the corporation, and
22	the rights and privileges of members of the corporation,
23	are as provided in the articles and bylaws of the corpora-
24	tion.

- 2 "(a) Board of Directors.—The composition of the
- 3 board of directors of the corporation, and the responsibil-
- 4 ities of the board, are as provided in the articles of incor-
- 5 poration and bylaws of the corporation.
- 6 "(b) Officers.—The positions of officers of the cor-
- 7 poration, and the election of the officers, are as provided
- 8 in such articles of incorporation and bylaws.

### 9 **"§ 230205. Powers**

- 10 "The corporation has only those powers provided in
- 11 its bylaws and articles of incorporation filed in each State
- 12 in which it is incorporated.

#### 13 **"§ 230206. Restrictions**

- 14 "(a) Stock and Dividends.—The corporation may
- 15 not issue stock or declare or pay a dividend.
- 16 "(b) Distribution of Income or Assets.—The in-
- 17 come or assets of the corporation may not inure to the
- 18 benefit of, or be distributed to, a director, officer, or mem-
- 19 ber of the corporation during the life of the charter grant-
- 20 ed by this chapter. This subsection shall not prevent the
- 21 payment of reasonable compensation to an officer or em-
- 22 ployee of the corporation, or reimbursement for actual
- 23 necessary expenses, in amounts approved by the board of
- 24 directors.
- 25 "(c) POLITICAL ACTIVITIES.—The corporation (or an
- 26 officer of the corporation, in the course of acting in such

1	capacity) may not contribute to, support, or participate
2	in any political activity.
3	"(d) Loans.—The corporation may not make a loan
4	to a director, officer, employee, or member of the corpora-
5	tion.
6	"(e) Claim of Governmental Approval or Au-
7	THORITY.—The corporation may not claim congressional
8	approval, or the authority of the United States, for any
9	of its activities.
10	"(f) Corporate Status.—The corporation shall
11	maintain its status as a corporation incorporated under
12	the laws of the State of California.

20	"The corporation shall submit to Congress an annual
21	report on the activities of the corporation during the pre-
22	ceding fiscal year. The report shall be submitted at the
23	same time as the report of the audit required by section
24	10101 of this title. The report may not be printed as a
25	public document.

- 2 "For purposes of this chapter, the term 'State' means
- 3 each of the several States, the District of Columbia, the
- 4 Commonwealth of Puerto Rico, or a territory or possession
- 5 of the United States.".
