3	"(a) Grants Authorized.—From amounts made
4	available to carry out this section, the Secretary shall
5	make grants to States, units of local government, Indian
6	Tribes, and neighborhood or community-based organiza-
7	tions to address adverse childhood experiences associated
8	with exposure to trauma.
9	"(b) USE OF FUNDS.—Amounts received under a
10	grant under this section may be used to establish an ad-
11	verse childhood experiences response team, including by—
12	"(1) establishing protocols to follow when en-
13	countering a child or youth exposed to trauma to fa-
14	cilitate access to services;
15	"(2) developing referral partnership agreements
16	with behavioral health providers, substance treat-

1	ment facilities, and recovery services for family
2	members of children exposed to trauma;
3	"(3) integrating law enforcement, mental
4	health, and crisis services to respond to situations
5	where children have been exposed to trauma;
6	"(4) implementing comprehensive programs and
7	practices to support children exposed to trauma;
8	"(5) identifying barriers for children to access
9	trauma-informed care in their communities;
10	"(6) providing training in trauma-informed care
11	to emergency response providers, victim service pro-
12	viders, child protective service professionals, edu-
13	cational institutions, and other community partners;
14	"(7) supporting cross-system planning and col-
15	laboration among officers and employees who work
16	in law enforcement, court systems, child welfare
17	services, correctional reentry programs, emergency
18	medical services, health care services, public health,
19	and substance abuse treatment and recovery sup-
20	port; and
21	"(8) providing technical assistance to commu-
22	nities, organizations, and public agencies on how to
23	prevent and mitigate the impact of exposure to trau-
24	ma and violence.

- 7 "(d) Authorization of Appropriations.—To
- 8 carry out this section, there is authorized to be appro-
- 9 priated \$10,000,000 for each of the fiscal years 2022
- 10 through 2025.".
