9	(2) in subsection (c), by adding at the end the
10	following new paragraphs:
11	"(3) Annual Report.—Not later than October
12	1, 2025, and annually thereafter, the Assistant Sec-
13	retary of Defense for Industrial Base Policy shall
14	submit to the congressional defense committees, the
15	Committee on Small Business of the House of Rep-
16	resentatives, and the Committee on Small Business
17	and Entrepreneurship of the Senate a report that in-
18	cludes the following for the year covered by the re-

8	Beginning with the report due October 1, 2029, and
9	every four years thereafter, the Assistant Secretary
10	of Defense for Industrial Base Policy shall submit to
11	the congressional defense committees, the Committee
12	on Small Business of the House of Representatives.
13	and the Committee on Small Business and Entrepre-
14	neurship of the Senate a report on overall efficacy
15	of the small business strategy required under such
16	section 4901, including trends and data analysis for
17	the period covered by the report relating to imple-
18	mentation and outcomes of the strategy.".
