14	TITLE II—MASS VIOLENCE
15	PREVENTION CENTER
16	SEC. 201. MASS VIOLENCE PREVENTION CENTER.
17	Part G of the Omnibus Crime Control and Safe
18	Streets Act of 1968 (34 U.S.C. 10211 et seq.) is amended
19	by adding at the end the following:
20	"SEC. 702. MASS VIOLENCE PREVENTION CENTER.
21	"(a) Establishment.—There is established in the
22	Department of Justice a Mass Violence Prevention Center,
23	which shall be supervised by the Director of Mass Violence
24	Prevention (in this section referred to as the 'Director'),

1	who shall be appointed by the Director of the Federal Bu-
2	reau of Investigation with the approval of the President.
3	"(b) AUTHORITY OF FBI DIRECTOR.—The Director
4	of the Federal Bureau of Investigation shall have author-
5	ity, direction, and control over the Mass Violence Preven-
6	tion Center and the Director of Mass Violence Prevention.
7	"(c) Reporting.—Not later than 1 year after the
8	date of the enactment of this section, and annually there-
9	after, the Director shall submit a report to the Attorney
10	General with respect to the following matters:
11	"(1) The budget and programs of the Mass Vio-
12	lence Prevention Center.
13	"(2) The activities of the Director under sub-
14	section (f).
15	"(3) The conduct of intelligence operations im-
16	plemented by other elements of the intelligence com-
17	munity.
18	"(d) Purpose.—The purpose of the Mass Violence
19	Prevention Center shall be as follows:
20	"(1) To serve as the primary organization in
21	the United States Government for analyzing and in-
22	tegrating all intelligence possessed or acquired by
23	the United States Government pertaining to threats
24	of mass violence.

1	"(2) To conduct strategic operational planning
2	for mass violence prevention, integrating all instru-
3	ments of Federal, State, and local law enforcement.
4	"(3) To recommend roles and responsibilities to
5	Federal, State, and local law enforcement partners
6	as part of its strategic operational planning duties to
7	lead departments or agencies, as appropriate, for
8	mass violence prevention that are consistent with ap-
9	plicable law and that support strategic operational
10	plans for mass violence prevention.
11	"(4) To ensure that Federal, State, and local
12	law enforcement agencies, have access to and receive
13	all-source intelligence support needed to execute
14	plans to prevent mass violence or perform inde-
15	pendent, alternative analysis on threats of mass vio-
16	lence, or for other purposes, as appropriate.
17	"(5) To serve as the central and shared knowl-
18	edge bank on known and suspected perpetrators of
19	mass violence, as well as the perpetrator's goals,
20	strategies, capabilities, and networks of contacts and
21	support.
22	"(e) Duties and Responsibilities of Direc-
23	TOR.—The Director shall—
24	"(1) provide strategic operational plans for
25	mass violence prevention efforts of the United States

1	Government and for the effective integration of mass
2	violence intelligence and operations across agency
3	boundaries;
4	"(2) advise the Attorney General on the extent
5	to which the mass violence prevention program rec-
6	ommendations and budget proposals of the depart-
7	ments, agencies, and elements of the United States
8	Government conform to the priorities established by
9	the President.
10	"(3) disseminate mass violence threat informa-
11	tion, including a current mass violence threat anal-
12	ysis, to the President, the Vice President, the Attor-
13	ney General, the Secretary of Homeland Security,
14	and other officials of the executive branch as appro-
15	priate, and to the appropriate committees of Con-
16	gress;
17	"(4) support the Department of Justice, and
18	other appropriate agencies, in fulfillment of their re-
19	sponsibilities to disseminate mass violence threat in-
20	formation, consistent with applicable law, Executive
21	orders, and other Presidential guidance to State and
22	local government officials, and other entities, and co-
23	ordinate dissemination of mass violence threat infor-
24	mation to State and local law enforcement agencies
25	as approved by the Attorney General:

1	"(5) consistent with priorities approved by the
2	President, establish requirements for the intelligence
3	community for the collection of mass violence threat
4	information; and
5	"(6) perform such other duties as the Attorney
6	General may prescribe or are prescribed by law.
7	"(f) RESOLUTION OF DISPUTES.—The Attorney Gen-
8	eral shall resolve disagreements between the Mass Violence
9	Prevention Center and the head of a department, agency,
10	or element of the United States Government on designa-
11	tions, assignments, plans, or responsibilities under this
12	section. The head of such a department, agency, or ele-
13	ment may appeal the resolution of the disagreement by
14	the Attorney General to the President.".

19	SEC. 301. ADDITIONAL ASSISTANT UNITED STATES ATTOR-
20	NEYS.
21	There are authorized to be appropriated for each of
22	fiscal years 2020, 2021, 2022, 2023, and 2024,
23	\$10,000,000 for the appointment of not fewer than 50 as-
24	sistant United States attorneys in such districts as the
25	Attorney General determines appropriate, based on the in-

- 1 cidence of firearms-related violence. The duties of any as-
- 2 sistant United States attorney appointed under this sec-
- 3 tion shall, for fiscal years 2020 through 2024, consist sole-
- 4 ly of assisting in the implementation of Project Safe
- 5 Neighborhoods in that district.
