At the end of the bill (before the short title), insert the following:

1 SEC. _____. (a) None of the funds made available by
2 this Act may be used—

11 of entry from the operational hours of 9:00 AM
12 to 10:00 PM CT daily;

13 (D) the Port of Neche, North Dakota, port
14 of entry from the operational hours of 8:00 AM
15 to 10:00 PM CT daily;

16 (E) the Port of Noonan, North Dakota,
17 port of entry from the operational hours of 9:00
18 AM to 10:00 PM CT daily;

1 (F) the Port of Northgate, North Dakota,
2 port of entry from the operational hours of 9:00
3 AM to 10:00 PM CT daily;

4 (G) the Port of Saint John, North Dakota,
5 port of entry from the operational hours of 8:00
6 AM to 9:00 PM CT daily;

7 (H) the Port of Sherwood, North Dakota,
8 port of entry from the operational hours of 9:00
9 AM to 10:00 PM CT daily;

10 (I) the Port of Walhalla, North Dakota,
11 port of entry from the operational hours of 8:00
12 AM to 10:00 PM CT daily;

13 (J) the Port of Westhope, North Dakota,
14 port of entry from the operational hours of 8:00
15 AM to 9:00 PM CT daily;

16 (K) the Port of Antler, North Dakota, port
17 of entry from the operational hours of 9:00 AM
18 to 10:00 PM CT daily;

19 (L) the Port of Sarles, North Dakota, port
20 of entry from the operational hours of 11:00
21 AM to 7:00 PM CT daily;

22 (M) the Port of Lancaster, Minnesota, port
23 of entry from the operational hours of 8:00 AM
24 to 10:00 PM CT daily;

1 (N) the Port of Roseau, Minnesota, port of
2 entry from the operational hours of 8:00 AM to
3 12:00 AM CT daily;

4 (O) the Porthill, Idaho, land Port of entry,
5 from the operational hours of 7:00 AM to 11:00
6 PM PT daily; or

7 (P) the Port of Buffalo, New York, port of
8 entry from the operational hours of 7:00 AM to
9 12:00AM ET daily;

10 (2) to implement, administer, enforce, carry
11 out, or execute any rules, guidance, decisions, an-
12 nouncements, or promulgations that reduce or
13 change the hours of operation at the ports of entry
14 specified in paragraph (1); or

15 (3) to publish, promulgate, or otherwise issue
16 rules, guidance, decisions, announcements, or pro-
17 mulgations that reduce or change the hours of oper-
18 ation at the ports of entry specified in paragraph
19 (1).

20 (b) The limitation described in paragraph (1) may
21 not be construed to apply in the case of the administration
22 of a tax or tariff.
