13	using either an internet voting system or a telephone

15	(3) National mediation board system.—If

7	(b) Report.— Not later than 180 days of the enact-
8	ment of this Act, and in each subsequent report under
9	Section 3(c) of the National Labor Relations Act, as
10	amended, the Board shall submit to Congress a report
11	containing a description of the following:
12	(1) For each representation petition under sec-
13	tion 9 of the National Labor Relations Act filed—
14	(A) the case name and case number;
15	(B) the number of days between the peti-
16	tion and the election;
17	(C) the number of days between the stipu-
18	lation or direction of election and the election;
19	(D) the method of the election;
20	(E) the results of the election; and
21	(F) the number of eligible voters, the num-
22	ber of voters participating in the election, and
23	the method by which each of the voters sub-
24	mitted their vote.

1	(2) The total cost of conducting all elections the
2	Board conducted through the system and procedures
3	required by subsection (a).
4	(c) Definitions.—In this section:
5	(1) Electronic voting system.—The term
6	"electronic voting system"—
7	(A) includes an internet voting system and
8	a telephone voting system; and
9	(B) does not include machines used for
10	casting votes at a polling site or an electronic
11	tabulation system where votes are cast non-elec-
12	tronically but counted electronically (such as a
13	punch card or optical scanning system).
14	(2) Internet voting system.—The term
15	"internet voting system" means an internet-based
16	voting system that allows a participant to cast a bal-
17	lot remotely using a personal computer or other mo-
18	bile electronic device that is connected to the inter-
19	net.
20	(3) TELEPHONE VOTING SYSTEM.—The term
21	"telephone voting system" means a voting system in
22	which participants may cast a vote remotely using a
23	telephone.
24	(4) Remotely.—The term "remotely", used
25	with respect to voting in a representation election,

means a vote may be cast at any site chosen by a
participant in such election.
(5) Representation election.—The term
"representation election" means a representation
election under section 9 of the National Labor Rela-
tions Act (29 U.S.C. 159).
