At the end of subtitle F of title V, add the following:

1	SEC. 560b. SUPPORT OF MILITARY SERVICE ACADEMY
2	FOUNDATIONS.
3	(a) In General.—Chapter 155 of title 10, United
4	States Code, is amended by adding at the end the fol-
5	lowing new section:
6	"§ 2616. Support of military service academy founda-
7	tions
8	"(a) Authority.—Subject to subsection (b), the
9	Secretary concerned may provide the following support to
10	a covered foundation:
11	"(1) Participation in fundraising or a member-
12	ship drive for the covered foundation by any—
13	"(A) general or flag officer;
14	"(B) Senior Executive Service employee
15	assigned to the service academy supported by
16	that covered foundation; or
17	"(C) official designated by the Secretary
18	concerned.

1	"(2) Endorsement by an individual described in
2	paragraph (1) of—
3	"(A) the covered foundation;
4	"(B) an event of the covered foundation;
5	or
6	"(C) an activity of the covered foundation.
7	"(b) Limitations.—Support under subsection (a)
8	may be provided only if such support—
9	"(1) is without any liability of the United
10	States to the covered foundation;
11	"(2) does not affect the ability of any official or
12	employee of the Department of Defense or the De-
13	partment of Homeland Security, or any member of
14	the armed forces, to carry out any responsibility or
15	duty in a fair and objective manner;
16	"(3) does not compromise the integrity or ap-
17	pearance of integrity of any program of the Depart-
18	ment of Defense or the Department of Homeland
19	Security, or any individual involved in such a pro-
20	gram; and
21	"(4) does not include the participation of any
22	cadet or midshipman.
23	"(c) Briefing.—In any fiscal year during which sup-
24	port is provided under subsection (a), the Secretary con-
25	cerned shall provide a briefing not later than the last day

1	of that fiscal year to the congressional defense committees
2	regarding the following:
3	"(1) The number of events, activities, or fund-
4	raising or membership drives of a covered founda-
5	tion in which an individual described in subsection
6	(a)(1) participated during such fiscal year.
7	"(2) The amount of funds raised for each cov-
8	ered foundation during each such event, activity, or
9	drive.
10	"(3) Each designated purpose of funds de-
11	scribed in paragraph (2).
12	"(d) Covered Foundation Defined.—In this sec-
13	tion, the term 'covered foundation' means a charitable,
14	educational, or civic nonprofit organization under section
15	501(e)(3) of the Internal Revenue Code of 1986, that the
16	Secretary concerned determines operates exclusively to
17	support, with respect to a military service academy, any
18	of the following:
19	"(1) Recruiting.
20	"(2) Parent or alumni development.
21	"(3) Academic, leadership, or character develop-
22	ment.
23	"(4) Institutional development.
24	"(5) Athletics.".

- 3 at the end the following new item:

"2616. Support of military service academy foundations.".
