At the end of subtitle C of title XVIII, insert the following:

3	(a) Additional Written Questions on Visa Ap-
4	PLICATION FORMS.—
5	(1) Nonimmigrant and immigrant visa ap-
6	PLICATION FORMS.—Not later than 180 days after
7	the date of enactment of this Act, the Secretary of
8	State shall revise the nonimmigrant and immigrant
9	visa application forms to include, for an alien who
10	indicates on such application that the alien's place
11	of birth or country of origin is Iran, questions on the
12	following:
13	(A) Whether the alien has ever served in
14	an official or unofficial capacity in the execu-
15	tive, parliamentary, or judicial branches of the
16	Iranian Government, or the Office of the Su-
17	preme Leader of the Islamic Republic of Iran,
18	including as an appointee, advisor, or assistant.

1	(B) In the case that the answer to the
2	question posed pursuant to subparagraph (A) is
3	yes, require an answer to each of the following:
4	(i) Whether the alien has ever per-
5	formed any law enforcement or national se-
6	curity functions for or on behalf of, di-
7	rectly or indirectly, the Islamic Republic of
8	Iran, including the police, or its special
9	units, or any state-sponsored vigilante or-
10	ganizations, such as Ansar-e Hezbollah.
11	(ii) Whether the alien has ever ren-
12	dered a financial transaction or trans-
13	actions, of any financial service to or for,
14	or on behalf of the Islamic Republic of
15	Iran in violation of United States sanc-
16	tions.
17	(iii) Whether the alien has ever ac-
18	quired or attempted to acquire any good,
19	service, or technology subject to United
20	States export control restrictions to or for
21	the Islamic Republic of Iran, including—
22	(I) sections 742.8 and 746.7 of
23	title 15, Code of Federal Regulations
24	(or any successor regulations); and

1	(II) sections 560.204 and
2	560.205 of title 31, Code of Federal
3	Regulations (or any successor regula-
4	tions).
5	(C) Whether the alien is or has been a
6	member of the Islamic Revolutionary Guard
7	Corps (in this section, referred to as "IRGC")
8	or any of its branches, including the IRGC
9	Aerospace Force, its Space Command or UAV
10	Command subunits, the IRGC Navy, the IRGC
11	Ground Force, the IRGC Quds Force, the
12	IRGC Intelligence Organization, the IRGC In-
13	telligence Protection Organization, the IRGC
14	Cyber-Defense Command, the IRGC Ansar al-
15	Mahdi Protection Unit, the IRGC Vali-e Amr
16	Unit, IRGC provincial commands, the Khatam
17	al-Anbiya Construction Headquarters, the
18	IRGC Cooperative Foundation, the Basij Re-
19	sistance Force or any of its subunits, such as
20	the Imam Hossein Brigades or the Imam Ali

7	(iii) Whether the alien has retained an
8	active-duty status with the IRGC or any of
9	its branches or affiliates described in sub-
10	paragraph (C).
11	(iv) Whether the alien has partici-
12	pated in recruiting members or activists on
13	behalf of the IRGC or any of its branches
14	or affiliates described in subparagraph (C).
15	(v) Whether the alien has been paid,
16	aside from conscription, for service ren-
17	dered to the IRGC or any of its branches
18	or affiliates described in subparagraph (C).
19	(b) Additional Written Questions on Applica-
20	TION TO REGISTER PERMANENT RESIDENCE OR ADJUST
21	Status.—Not later than 180 days after the date of enact-
22	ment of this Act, the Secretary of Homeland Security shall

24	or adjust status a question on whether the alien has ever
