

AMENDMENT TO RULES COMM. PRINT 117-13
OFFERED BY MR. BARR OF KENTUCKY

Add at the end of subtitle E of title XII of division
A the following:

1 **SEC. 12 ____ . REPORT ON INTELLIGENCE MATTERS REGARD-**
2 **ING TAIWAN.**

3 (a) IN GENERAL.—Consistent with section 3(c) of the
4 Taiwan Relations Act (Public Law 96-8; 22 U.S.C.
5 3302(c)), and consistent with the protection of intelligence
6 sources and methods, not later than 180 days after the
7 date of the enactment of this Act, the Director of National
8 Intelligence, in consultation with the Secretary of Defense,
9 shall submit to the congressional defense committees, the
10 Permanent Select Committee on Intelligence and the Com-
11 mittee on Foreign Affairs of the House of Representatives,
12 and the Select Committee on Intelligence and the Com-
13 mittee on Foreign Relations of the Senate a report on
14 any—

15 (1) influence operations conducted by China to
16 interfere in or undermine peace and stability of the
17 Taiwan Strait and the Indo-Pacific region; and

18 (2) efforts by the United States to work with
19 Taiwan to disrupt such operations.

1 (b) ELEMENTS.—The report required by subsection
2 (a) shall include the following:

3 (1) A description of any significant efforts by
4 the intelligence community (as such term is defined
5 in section 3(4) of the National Security Act of 1947
6 (50 U.S.C. 3003(4))) to coordinate technical and
7 material support for Taiwan to identify, disrupt, and
8 combat influence operations referred to in subsection
9 (a)(1).

10 (2) A description of any efforts by the United
11 States Government to build the capacity of Taiwan
12 to disrupt external efforts that degrade its free and
13 democratic society.

14 (3) An assessment to achieve measurable
15 progress in enhancing the intelligence community's
16 cooperation with Taiwan, including through—

17 (A) development of strategies to engage
18 Taiwan in the discussions of United States-
19 leading intelligence forums or dialogues;

20 (B) an evaluation of the feasibility of co-
21 operating with Taiwan in the Mandarin lan-
22 guage education and training for the United
23 States' intelligence community through the For-
24 eign Language Incentive Program and pro-

1 grams under the Intelligence Language Insti-
2 tute; and

3 (C) implementing steps to increase ex-
4 changes and mutual visits between the intel-
5 ligence communities of the United States and
6 Taiwan at all levels in accordance with the Tai-
7 wan Travel Act (Public Law 115–135)

8 (c) FORM.—The report required by subsection (a)
9 shall be submitted in unclassified form, but may include
10 a classified annex.
