

AMENDMENT TO RULES COMM. PRINT 118-36
OFFERED BY MR. BARR OF KENTUCKY

At the end of subtitle B of title XVII, add the following new section:

1 **SEC. 17 ____ . TAIWAN STRAIT DESTABILIZATION ACT.**

2 (a) REPORT.—Not later than 1 year after the date
3 of the enactment of this Act, the Secretary of Defense,
4 in consultation with the Secretary of State and the Direc-
5 tor of the Bureau of Economic Analysis of the Department
6 of Commerce, shall conduct a study and submit to the ap-
7 propriate congressional committees and transmit to the
8 United States representatives at relevant international or-
9 ganizations, as appropriate, a report on the global eco-
10 nomic impact of a blockade and invasion of Taiwan by
11 the People’s Republic of China that includes—

12 (1) an assessment of the effects to the United
13 States and global financial sector as a result of a
14 blockade or invasion of Taiwan by the People’s Re-
15 public of China;

16 (2) an assessment of the effects to United
17 States and global semiconductor sector as a result of
18 a blockade or invasion of Taiwan by the People’s Re-
19 public of China;

1 (3) an assessment of the effects to job losses
2 within the United States as a result of a blockade
3 or invasion of Taiwan by the People's Republic of
4 China;

5 (4) an assessment of the effects to regional sta-
6 bility of the Indo-Pacific as a result of a blockade
7 or invasion of Taiwan by the People's Republic of
8 China;

9 (5) a description of the policies the United
10 States Government is adopting to protect the eco-
11 nomic interests of the United States, the global
12 semiconductor sector, and the regional stability of
13 the Indo-Pacific, in the event of a blockade or inva-
14 sion of Taiwan by the People's Republic of China;

15 (6) a description and analysis of any risks to
16 the interests of the United States, the global semi-
17 conductor industry, and other major economic sec-
18 tors emanating from Taiwan that would be impacted
19 in the event of a blockade or invasion of Taiwan by
20 the People's Republic of China; and

21 (7) recommendations for additional actions the
22 United States Government, including United States
23 representatives at relevant international organiza-
24 tions, should take to mitigate or prevent such out-
25 comes, as well as protect the interests of the United

1 States, in the event of the event of a blockade or in-
2 vasion of Taiwan by the People’s Republic of China.

3 (b) FORM; PUBLICATION.—

4 (1) FORM.—The report required by subsection
5 (a) shall be unclassified, but may contain a classified
6 annex.

7 (2) PUBLICATION.—The Secretary of the De-
8 fense shall publish the unclassified portion of the re-
9 port required under subsection (a) on a website of
10 the Department of the Defense not later than 1 year
11 after the date of enactment of this Act.

12 (c) APPROPRIATE CONGRESSIONAL COMMITTEES DE-
13 FINED.—In this section, the term “appropriate congres-
14 sional committees” means the Committee on Foreign Af-
15 fairs of the House of Representatives and the Committees
16 on Foreign Relations of the Senate.
