## OFFERED BY MR. BERA OF CALIFORNIA

At the end of subtitle B of title XVII, insert the following:

1	SEC. 17 REPORT ON PROMOTION OF UNITED STATES
2	POLICIES ON EFFECTS OF SEA-LEVEL RISE
3	ON STATEHOOD AND MARITIME ZONES.
4	(a) STATEMENT OF POLICY.—It is the policy of the
5	United States that—
6	(1) sea-level rise driven by human-induced cli-
7	mate change should not cause any country to lose its
8	statehood or its membership in the United Nations,
9	its specialized agencies, or other international orga-
10	nizations;
11	(2) sea-level rise driven by human-induced cli-
12	mate change should not diminish the maritime zones
13	on which island States and other coastal States rely,
14	including for food and livelihoods;
15	(3) the United States is committed to pre-
16	serving the legitimacy of maritime zones, and associ-
17	ated exclusive rights to resources and entitlements,
18	that have been established consistent with inter-

1	national law as reflected in the United Nations Con-
2	vention on the Law of the Sea ?and that are not
3	subsequently updated to reflect sea-level rise caused
4	by climate change;
5	(4) countries adopt policies that reflect the ap-
6	proach of?the Pacific Islands Forum and the Alli-
7	ance of Small Island States to maintain maritime
8	zones delineated in accordance with international
9	law as reflected by the United Nations Convention
10	on the Law of the Sea, and preserve the rights and
11	entitlements that flow from them, in the context of
12	sea-level rise driven by human-induced climate
13	change;
14	(5) countries adopt policies that reflect the ap-
15	proach of?the Pacific Islands Forum and the Alli-
16	ance of Small Island States to affirm that inter-
17	national law supports a presumption of continuity of
18	statehood and does not contemplate its demise in the
19	context of sea-level rise driven by human-induced cli-
20	mate change; and
21	(6) the United States will work with countries
22	to establish policies to promote the continuity of
23	statehood and the preservation of maritime zones de-
24	lineated in accordance with the United Nations Con-
25	vention on the Law of the Sea that cannot be chal-

1 lenged or reduced by sea-level rise driven by human-2 induced climate change. 3 (b) Report.— 4 (1) IN GENERAL.—Not later than 120 days 5 after the date of the enactment of this Act, the Sec-6 retary of State and Secretary of Defense, in con-7 sultation with the heads of other relevant Federal 8 agencies, shall submit to the appropriate congres-9 sional committees a report on the efforts of the 10 United States to promote United States policies on 11 the effects of sea-level rise on statehood and mari-12 time zones. Such report shall include each of the fol-13 lowing: 14 (A) A comprehensive review of initiatives 15 the Department of State, Department of De-16 fense, and other relevant departments and 17 agencies are taking to promote the adoption of 18 United States policies on sea-level rise and 19 statehood and maritime zones by countries and 20 international organizations. 21 (B) An assessment of how the Department 22 of State, Department of Defense, and other rel-23 evant departments and agencies are establishing 24 new or expanding existing bilateral and multi-25 lateral efforts to encourage adoption of United

2	and maritime zones in international fora.
3	(C) An assessment of any legal, policy
4	logistical, financial, or administrative barriers
5	to promoting the adoption of United States
6	policies on sea-level rise and statehood and
7	maritime zones.
8	(D) A list of countries and international
9	organizations that have adopted policies that re-
10	flect the approach of the United States on the
11	effects of sea-level rise on statehood and mari-
12	time zones.
13	(2) FORM OF REPORT.—The report required
14	under paragraph (1) shall be submitted in unclassi-
15	fied form, but may include a classified annex.
16	(3) Appropriate congressional commit-
17	TEES.—In this section, the term "appropriate con-
18	gressional committees" means—
19	(A) the Committee on Foreign Affairs and
20	the Committee on Armed Services of the House
21	of Representatives; and
22	(B) the Committee on Foreign Relations
23	and the Committee on Armed Services of the
24	Senate.
