At the end of title XVII, add the following new section:

3	(a) In General.—Section 6320 of title 38, United
4	States Code, is amended, in subsection (a)—
5	(1) in paragraph (1), by inserting "members of
6	the Armed Forces described in subsection (b) and"
7	after "needs of"; and
8	(2) in paragraph (2)—
9	(A) in the matter preceding subparagraph
10	(A)—
11	(i) by inserting "with the Department
12	of Defense" after "coordinate efforts"; and
13	(ii) by inserting "such members of the
14	Armed Forces and" after "to assist";
15	(B) in subparagraph (A), by inserting
16	"such members and" after "reach out to"; and
17	(C) in subparagraph (B), by inserting
18	"such members and" after "to connect"

1	(b) Activities of the Solid Start Program.—
2	Such section is further amended, in subsection (b)(1)—
3	(1) in subparagraph (A), by inserting "(with
4	priority for members between during the period be-
5	tween 120 and 210 days before separation)" after
6	"separating from the Armed Forces";
7	(2) in subparagraph (D), by inserting "such
8	member's and" after "the needs of each";
9	(3) in subparagraph (E), by inserting "such
10	members and" after "prioritizing outreach to";
11	(4) in subparagraph (F), by inserting "such
12	members who are women and" after "providing".
13	(5) by redesignating subparagraphs (B)
14	through (H) as subparagraphs (E) through (K), re-
15	spectively; and
16	(6) by inserting after subparagraph (A) the fol-
17	lowing new subparagraphs:
18	"(B) collecting suicide prevention policies,
19	points of contact, and referral protocols of the De-
20	partment of Defense to inform such members who
21	are in crisis of such resources;
22	"(C) calling each such member, regardless of
23	separation type or characterization of service, at
24	least one time not earlier than 210 days, and not

1	later than 120 days, before the separation of such
2	member from the Armed Forces—
3	"(i) to inform the member of the transi-
4	tional health care available under section 1145
5	of title 10; and
6	"(ii) to provide to the member the contact
7	information for—
8	"(I) the facility of the Department lo-
9	cated closest to the member's permanent
10	residence; and
11	"(II) a local representative of an orga-
12	nization recognized by the Secretary under
13	section 5902 of this title, or an agent or
14	attorney recognized under section 5904 of
15	this title, who may assist the member in
16	compiling and filing the member's claim
17	for disability compensation;
18	"(D) communicating with such members
19	through other means (including text message or
20	email) if calling each member as described in sub-
21	paragraph (C) has not resulted in contact before ex-
22	ceeding the maximum number of call attempts as
23	the Secretary may specify;".
