

**AMENDMENT TO**  
**RULES COMMITTEE PRINT 119-8**  
**OFFERED BY MR. BILIRAKIS OF FLORIDA**

At the end of subtitle A of title VI, add the following  
new section:

1 **SEC. 6\_\_ . ELIGIBILITY OF DISABILITY RETIREES WITH**  
2 **COMBAT-RELATED DISABILITIES FOR CON-**  
3 **CURRENT RECEIPT OF VETERANS' DIS-**  
4 **ABILITY COMPENSATION AND RETIRED PAY.**

5 (a) CONCURRENT RECEIPT IN CONNECTION WITH  
6 CRSC.—Section 1413a(b) of title 10, United States Code,  
7 is amended by striking paragraph (3).

8 (b) CONCURRENT RECEIPT GENERALLY.—Section  
9 1414(b) of title 10, United States Code, is amended by  
10 striking paragraph (2) and inserting the following new  
11 paragraphs:

12 “(2) COMBAT-RELATED RETIREES.—An eligible  
13 combat-related disabled uniformed services retiree  
14 (as defined in section 1413a(c) of this title) who is  
15 retired under chapter 61 of this title, is entitled to  
16 retired pay under chapter 61 of this title for any  
17 month, and is also entitled for that month to vet-  
18 erans' disability compensation under title 38, is enti-

1 tled to be paid both such retired pay and such vet-  
2 erans' disability compensation for that month with-  
3 out regard to sections 5304 and 5305 of title 38.

4 “(3) EXCLUSION OF OTHER RETIREES.—Sub-  
5 section (a) does not apply to a member retired under  
6 chapter 61 of this title if the member is not covered  
7 by paragraph (1) or (2).”.

8 (c) TECHNICAL AND CONFORMING AMENDMENTS.—

9 (1) AMENDMENTS REFLECTING END OF CON-  
10 CURRENT RECEIPT PHASE-IN PERIOD.—Section  
11 1414 of title 10, United States Code, is further  
12 amended—

13 (A) in subsection (a)(1)—

14 (i) by striking the second sentence;

15 and

16 (ii) by striking subparagraphs (A) and

17 (B);

18 (B) by striking subsection (c) and redesignig-  
19 nating subsections (d) and (e) as subsections  
20 (e) and (d), respectively; and

21 (C) in subsection (d), as redesignated, by  
22 striking paragraphs (3) and (4).

23 (2) SECTION HEADING.—The heading of such  
24 section 1414 is amended to read as follows:

1 **“§ 1414. Members eligible for retired pay who are also**  
2 **eligible for veterans’ disability compensa-**  
3 **tion: concurrent receipt”.**

4 (3) CONFORMING AMENDMENT.—Section  
5 1413a(f) of such title is amended by striking “Sub-  
6 section (d)” and inserting “Subsection (e)”.

7 (d) EFFECTIVE DATE.—The amendments made by  
8 this section shall take effect on the first day of the first  
9 month beginning after the date of the enactment of this  
10 Act and shall apply to payments for months beginning on  
11 or after that date.
