6	(A) by amending clause (ii) to read as fol-

8	"(ii) was or is employed in Afghani-
9	stan on or after October 7, 2001, for not
10	less than 1 year—
11	"(I) by, or on behalf of, the
12	United States Government;
13	"(II) by, or on behalf of, an orga-
14	nization or entity closely associated
15	with the United States mission in Af-
16	ghanistan that has received United
17	States Government funding through
18	an official and documented contract,
19	award, grant, or cooperative agree-

2	curity Assistance Force; or
3	"(III) by, or on behalf of, a
4	media or nongovernmental organiza-
5	tion headquartered in the United

7	(B) in clause (iii), by striking "the United
8	States Government" and inserting "an entity or
9	organization described in clause (ii)"; and
10	(C) in clause (iv), by striking "by the
11	United States Government" and inserting "de-
12	scribed in clause (ii)"; and
13	(2) by amending paragraph $(3)(D)$ to read as
14	follows:
15	"(D) ADDITIONAL FISCAL YEARS.—For
16	fiscal year 2014, the total number of principal
17	aliens who may be provided special immigrant
18	status under this section may not exceed 3,000
19	per year, and for fiscal year 2015, the total
20	number of principal aliens who may be provided
21	special immigrant status under this section may
22	not exceed 1,075 per year, except that—
23	"(i) notwithstanding subparagraph
24	(C), any unused balance of the total num-
25	ber of principal aliens who may be pro-
