At the end of subtitle F of title X, insert the following:

1 **SEC. 10__ . PUBLIC AVAILABILITY OF INFORMATION**
2 **ABOUT COST OF UNITED STATES OVERSEAS**
3 **MILITARY FOOTPRINT.**

4 Section 1090 of the National Defense Authorization
5 Act for Fiscal Year 2017 (Public Law 114–328) is amend-
6 ed by adding at the end the following new subsections:

7 “(c) **ADDITIONAL INFORMATION.**—For fiscal year
8 2023 and each subsequent fiscal year, the Secretary of De-
9 fense, in consultation with the Commissioner of the Inter-
10 nal Revenue Service and the Director of the Bureau of
11 Economic Analysis, shall post on the public Internet
12 website of the Department of Defense the costs to each
13 United States taxpayer of the overseas military footprint
14 of the United States, including—

15 “(1) the costs of building, maintaining, staffing
16 and operating all overseas military bases and instal-
17 lations;

1 “(2) the personnel costs, including compensa-
2 tion, housing and health care, for all members of the
3 Armed Forces deployed overseas at any point
4 throughout the fiscal year;

5 “(3) the costs paid to contractors providing
6 goods and services in support of overseas military
7 bases, installations, and operations;

8 “(4) the costs of conducting all overseas mili-
9 tary operations, including operations conducted by
10 United States Armed Forces, operations conducted
11 using unmanned weapons systems, covert operations,
12 and operations undertaken by, with, and through
13 partner forces;

14 “(5) the costs of all overseas military exercises
15 involving United States Armed Forces; and

16 “(6) the costs of all military training and as-
17 sistance provided by the United States to overseas
18 partner forces.

19 “(d) DISPLAY OF INFORMATION.—The information
20 required to be posted under subsections (a) and (c) shall—

21 “(1) be posted directly on the website of the
22 Department of Defense, in an accessible and clear
23 format;

24 “(2) include corresponding documentation as
25 links or attachments; and—

1 “(3) include, for each overseas operation—

2 “(A) both the total cost to each taxpayer,
3 and the cost to each taxpayer for each fiscal
4 year, of conducting the overseas operation;

5 “(B) a list of countries where the overseas
6 operations have taken place; and

7 “(C) for each such country, both the total
8 cost to each taxpayer, and the cost to each tax-
9 payer for each fiscal year, of conducting the
10 overseas operations in that country.”.
