

**AMENDMENT TO DIVISION A OF RULES**  
**COMMITTEE PRINT 116-17**  
**OFFERED BY MR. BUCHANAN OF FLORIDA**

At the end of division A (before the short title), insert the following:

1       SEC. \_\_\_\_\_. (a) GRANTS FOR AN INNOVATIVE DEM-  
2       ONSTRATION PILOT PROGRAM TO PROVIDE TRAUMA-IN-  
3       FORMED INTERVENTIONS TO CHILDREN WHO HAVE  
4       BEEN ABUSED, NEGLECTED, OR ABANDONED.—Section  
5       437 of the Social Security Act (42 U.S.C. 629g) is amend-  
6       ed by adding at the end the following:

7       “(h) GRANTS FOR AN INNOVATIVE DEMONSTRATION  
8       PILOT PROGRAM TO PROVIDE TRAUMA-INFORMED INTER-  
9       VENTIONS TO CHILDREN WHO HAVE BEEN ABUSED, NE-  
10      GLECTED, OR ABANDONED.—

11           “(1) PURPOSE.—The purpose of this subsection  
12      is to facilitate the development of an innovative pilot  
13      demonstration program to provide trauma-informed  
14      interventions to children who have been abused, ne-  
15      glected, or abandoned..

16           “(2) APPLICATION REQUIREMENTS.—An entity  
17      that desires a grant under this subsection shall sub-

1 mit to the Secretary an application containing the  
2 following:

3 “(A) A description of the goals and out-  
4 comes to be achieved during the period for  
5 which grant funds are sought

6 “(B) A description of the activities to be  
7 funded in whole or in part with the grant  
8 funds, including the sequencing of the activities.

9 “(C) A description of collaboration with  
10 entities that provide research rooted in brain  
11 science to develop effective trauma-informed  
12 interventions for children who have experienced  
13 abuse, neglect, or abandonment.

14 “(D) Such other information as the Sec-  
15 retary may require.

16 “(3) GRANT AUTHORITY.—The Secretary may  
17 make a grant to a State that complies with para-  
18 graph (2).”.

19 (b) RESERVATION OF FUNDS FOR A PILOT PROGRAM  
20 TO PROVIDE TRAUMA-INFORMED INTERVENTIONS TO  
21 CHILDREN WHO HAVE BEEN ABUSED, NEGLECTED, OR  
22 ABANDONED.—Section 437(b) of such Act (42 U.S.C.  
23 629g(b)) is amended by adding at the end the following:

24 “(4) PILOT PROGRAM TO PROVIDE TRAUMA-IN-  
25 FORMED INTERVENTIONS TO CHILDREN WHO HAVE

1       BEEN ABUSED, NEGLECTED, OR ABANDONED.—The  
2       Secretary shall reserve \$5,000,000 of the amount  
3       made available for fiscal year 2020 for grants under  
4       subsection (g), and the amount so reserved shall re-  
5       main available through fiscal year 2023.”.
