**OFFERED BY MR. BURGESS OF TEXAS**

Page 21, strike line 17 and all that follows through page 30, line 9, and insert the following:

1 **SEC. 13. PROMOTING AFFORDABLE ENERGY, ENERGY EFFI-**  
2 **CIENCY, AND CLEAN ENERGY EXPORTS.**

3 (a) OFFICE OF ENERGY EFFICIENCY AND CLEAN  
4 ENERGY EXPORTS.—Section 2(b)(1)(C) of the Export-Im-  
5 port Bank Act of 1945 (12 U.S.C. 635(b)(1)(C)) is  
6 amended to read as follows:

7 “(C) OFFICE OF ENERGY EFFICIENCY AND CLEAN  
8 ENERGY EXPORTS.—The President of the Agency shall  
9 establish an office whose functions shall be to—

10 “(i) advise the Board of Directions on ways of  
11 promoting the export of goods and services to be  
12 used in the development, production, and distribu-  
13 tion of energy efficiency and clean energy resources;

14 “(ii) disseminate information concerning export  
15 opportunities and the availability of Agency support  
16 for such activities; and

17 “(iii) act as a liaison between the Agency and  
18 the Department of Commerce and other appropriate

1 departments and agencies of the Federal Govern-  
2 ment.”.

3 (b) AFFORDABLE ENERGY.—Section 11(a) of such  
4 Act (12 U.S.C. 635i–5(a)) is amended—

5 (1) by redesignating paragraph (2) as para-  
6 graph (3) and inserting after paragraph (1) the fol-  
7 lowing:

8 “(2) AFFORDABILITY OF ENERGY CONSIDER-  
9 ATION.—The Agency shall establish procedures to  
10 consider, concurrently with compliance with the pro-  
11 cedures established under paragraph (1), potential  
12 increases to energy prices resulting from the export  
13 of any good or service supported by the Agency.”;  
14 and

15 (2) in paragraph (3) (as so redesignated)—

16 (A) by striking “paragraph (1)” and in-  
17 serting “this subsection”;

18 (B) by inserting “or energy affordability”  
19 after “environmental” the 1st place it appears;  
20 and

21 (C) by inserting “and energy affordability”  
22 after “environmental” the 2nd place it appears.

23 (c) ANNUAL REPORT TO CONGRESS.—Section 11(c)  
24 of such Act (12 U.S.C. 635i–5(c)) is amended to read as  
25 follows:

1       “(c) INCLUSION IN ANNUAL REPORT TO CON-  
2 GRESS.—The Agency shall include in its annual report to  
3 Congress under section 8 a report on the following:

4               “(1) Whether the provision by the Agency of fi-  
5 nancing for the goods and services described in sec-  
6 tion 2(b)(1)(C)(i) have increased energy affordability  
7 in the countries to which the goods and services have  
8 been exported.

9               “(2) An estimate of any reductions in emissions  
10 (including emissions of sulfur dioxide, nitrogen diox-  
11 ide, greenhouse gases, particulates, and lead) result-  
12 ing from the provision by the Agency of financing  
13 for the goods and services referred to in paragraph  
14 (1) of this subsection.”.
