

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 3361
OFFERED BY MR. CARNEY OF DELAWARE**

After section 604, insert the following new section:

1 **SEC. 605. ANNUAL REPORT BY THE COMPTROLLER GEN-**
2 **ERAL ON PROGRAMS UNDER THE FOREIGN**
3 **INTELLIGENCE SURVEILLANCE ACT OF 1978.**

4 (a) REPORT.—Title VI (50 U.S.C. 1871 et seq.), as
5 amended by section 604 of this Act, is further amended
6 by adding at the end the following new section:

7 **“SEC. 605. ANNUAL REPORT BY THE COMPTROLLER GEN-**
8 **ERAL.**

9 “(a) REPORT.—The Comptroller General of the
10 United States shall annually submit to the Permanent Se-
11 lect Committee on Intelligence and the Committee on the
12 Judiciary of the House of Representatives and the Select
13 Committee on Intelligence and the Committee on the Judi-
14 ciary of the Senate a report on the effectiveness of the
15 programs and activities carried out under this Act.

16 “(b) CONTENTS.—Each report under subsection (a)
17 shall include—

18 “(1) an analysis of the restrictions placed on
19 access to information obtained under this Act;

1 “(2) the number of incidents of non-compliance
2 with this Act or any rule, regulation, policy, or pro-
3 cedure to carry out this Act;

4 “(3) a description of actions taken in response
5 to incidents of non-compliance described in para-
6 graph (2);

7 “(4) a description of the minimization proce-
8 dures used to carry out each provision of this Act;

9 “(5) a description of how such minimization
10 procedures are verified to be in use and effective;

11 “(6) the number of applications made under
12 each appropriate provision of this Act, the number
13 of such applications approved by a court, and the
14 number of times such applications resulted in an
15 oral argument before the court;

16 “(7) the number of times employees of or con-
17 tractors to the National Security Agency search in-
18 formation acquired under this Act; and

19 “(8) any other information the Comptroller
20 General considers appropriate.

21 “(c) PUBLIC DISCLOSURE.—At the time of submis-
22 sion of each report required under subsection (a), the
23 Comptroller General shall make publicly available an un-
24 classified summary of such report.”.

1 (b) TABLE OF CONTENTS AMENDMENT.—The table
2 of contents in the first section, as amended by section 604
3 of this Act, is further amended by inserting after the item
4 relating to section 604, as added by section 604 of this
5 Act, the following new item:

“Sec. 605. Annual report by the Comptroller General.”.
