

AMENDMENT TO RULES COMMITTEE PRINT
118-11
OFFERED BY MR. CARTWRIGHT OF
PENNSYLVANIA

At the end of title VIII, add the following:

1 **SEC. __. EDUCATION PROGRAM ON UNLEADED GASOLINE.**

2 (a) IN GENERAL.—Not later than 1 year after the
3 date of enactment of this Act, the Administrator of the
4 Federal Aviation Administration shall establish and dis-
5 seminate an education program to provide general aviation
6 pilots, flight schools, airport managers and operators, air-
7 craft maintenance technicians, fixed-base operators, and
8 other members of the general aviation community with in-
9 formation about new unleaded aviation gasoline certified
10 by the Administrator.

11 (b) REQUIREMENTS.—

12 (1) IN GENERAL.—In establishing the education
13 program under subsection (a), the Administrator
14 shall publish on a website of the Administration in-
15 formation about certified unleaded aviation gasoline,
16 including—

17 (A) information about the compatibility of
18 such gasoline with aircraft engines;

1 (B) the status of all variations of unleaded
2 aviation gasoline undergoing certification and
3 approval by the Administration;

4 (C) information about when new brands or
5 variations of unleaded aviation gasoline prod-
6 ucts become available for purchase and the lo-
7 cations where such gasoline is available;

8 (D) a list of any relevant certification, in-
9 cluding supplemental type certificates, required
10 for a general aviation pilot to use such gasoline;

11 (E) educational information on how to use
12 unleaded aviation gasoline safely; and

13 (F) information about the availability of
14 any Federal initiatives or incentives (including
15 tax credits) relating to such gasoline.

16 (2) CERTIFICATION TRACKING MECHANISM.—
17 The Administrator shall make the information de-
18 scribed in paragraph (1)(B) available through a pub-
19 licly available and continuously updated certification
20 tracking mechanism.

21 (3) PUBLIC AVAILABILITY.—The Administrator
22 shall continuously update the information described
23 in paragraph (1) and ensure such information is
24 made available to—

25 (A) flight schools;

1 (B) fixed-base operators and the employees
2 of such operators;

3 (C) general aviation aircraft users, aircraft
4 owners, aircraft pilots, and aircraft operators;
5 and

6 (D) the general public.

7 (c) FLIGHT TRAINING.—The Administrator shall—

8 (1) require that the information described in
9 subsection (b) be included as part of flight training;
10 and

11 (2) require fixed-based operators to provide an-
12 nual education and training to leadership and staff
13 to ensure that individuals assisting with transporting
14 and handling unleaded aviation gasoline are in-
15 formed of fuel type differences and the impacts such
16 fuels have on airplanes.

17 (d) REPORT.—Not later than 6 months after the Ad-
18 ministrator establishes the education program under sub-
19 section (a), and annually thereafter, the Administrator
20 shall submit to Committee on Transportation and Infra-
21 structure of the House and Committee of Commerce,
22 Science, and Transportation of the Senate a report con-
23 taining the status of, and any findings with respect to,
24 such program, including the following elements: —

1 (1) A year-to-date frequency of updates to the
2 Administration website and information rollout to
3 flight schools and fixed-base operators.

4 (2) The progress of unleaded aviation gasoline
5 currently undergoing a certification or approval
6 process by the Administrator.

7 (3) An estimated total number of pilots using
8 unleaded aviation gasoline presumed or at least par-
9 tially as a result of such program.

10 (4) The estimated reach of such program.
