Page 124, after line 12, insert the following:

1 “(b) NATIONAL SECURITY INFORMATION SHAR-
2 ING.—

3 “(1) IN GENERAL.—Subsection (a) shall not
4 apply to a person directly or indirectly engaging in
5 an activity described under paragraph (2) or (4) of
6 subsection (a), unless the person discloses to the
7 Commission—

8 “(A) whether the person operates a facility
9 within 5 miles of a military installation and, if
10 so, the address of such facility;

11 “(B) whether the person is owned by a for-
12 eign person or entity; and

13 “(C) whether the person plans to begin op-
14 erating a new facility within 5 miles of a mili-
15 tary installation.

16 “(2) TIMING OF DISCLOSURES.—A person
17 meets the disclosure requirements under paragraph
18 (1) if the person makes a disclosure—

1 “(A) not later than 30 days after the date
2 of enactment of this subsection; and

3 “(B) not later than 30 days after begin-
4 ning to operate a new facility within 5 miles of
5 a military installation.

6 “(3) SHARING OF DISCLOSURE INFORMA-
7 TION.—The Commission shall provide the informa-
8 tion disclosed under this subsection to the Secretary
9 of the Treasury, the Financial Crimes Enforcement
10 Network, and the Committee on Foreign Investment
11 in the United States.

12 “(4) MILITARY INSTALLATION DEFINED.—In
13 this subsection, the term ‘military installation’
14 means a location contained on the list titled ‘List of
15 Military Installations and Other U.S. Government
16 Sites’ under appendix A to part 802 of title 31,
17 Code of Federal Regulations.”.

Page 219, after line 5, insert the following:

18 “(b) NATIONAL SECURITY INFORMATION SHAR-
19 ING.—

20 “(1) IN GENERAL.—Subsection (a) shall not
21 apply to a person directly or indirectly engaging in
22 an activity described under paragraph (2) or (4) of
23 subsection (a), unless the person discloses to the
24 Commission—

1 “(A) whether the person operates a facility
2 within 5 miles of a military installation and, if
3 so, the address of such facility;

4 “(B) whether the person is owned by a for-
5 eign person or entity; and

6 “(C) whether the person plans to begin op-

9 “(2) TIMING OF DISCLOSURES.—A person

17 “(3) SHARING OF DISCLOSURE INFORMA-
18 TION.—The Commission shall provide the informa-
19 tion disclosed under this subsection to the Secretary
20 of the Treasury, the Financial Crimes Enforcement
21 Network, and the Committee on Foreign Investment
22 in the United States.

23 “(4) MILITARY INSTALLATION DEFINED.—In
24 this subsection, the term ‘military installation’
25 means a location contained on the list titled ‘List of
