

AMENDMENT TO RULES COMMITTEE PRINT 119-8
OFFERED BY MR. CRANE OF ARIZONA

At the end of subtitle A of title XVII, add the following new section:

1 **SEC. 17 ____ . TEMPORARY AUTHORITIES RELATING TO PRO-**
2 **TECTION OF CERTAIN WORLD CUP FACILI-**
3 **TIES FROM UNMANNED AIRCRAFT SYSTEMS.**

4 (a) DEPARTMENT OF DEFENSE AUTHORITIES.—

5 (1) TEMPORARY AUTHORITY.—During the cov-
6 ered period, the Secretary of Defense may exercise
7 with respect to a covered World Cup facility the au-
8 thority under section 130i of title 10, United States
9 Code, to the same extent, and, except as provided in
10 paragraph (2), subject to the same conditions and
11 limitations as the Secretary may exercise such au-
12 thority with respect to a covered facility or asset
13 under such section.

14 (2) COORDINATION; TEMPORARY WAIVER OF
15 CERTAIN PRIVACY LIMITATIONS.—

16 (A) COORDINATION.—In exercising the au-
17 thority under section 130i of title 10, United
18 States Code, during the covered period with re-
19 spect to a covered World Cup facility, the Sec-

1 retary shall coordinate with the Director of the
2 Federal Bureau of Investigation and the head
3 of any State, local, or Tribal law enforcement
4 agency with jurisdiction over the area in which
5 the covered World Cup facility is located.

6 (B) TEMPORARY WAIVER OF CERTAIN PRI-
7 VACY LIMITATIONS.—During the covered pe-
8 riod, the Secretary may waive the applicability
9 of one or more regulations specified in sub-
10 section (e) of section 130i of title 10, United
11 States Code, (relating to privacy protection) to
12 the exercise of the authority under subsection
13 (b)(1)(A) of such section for the detection of an
14 unmanned aircraft system or unmanned aircraft
15 to mitigate a threat posed by such system or
16 aircraft to the safety or security of a covered
17 World Cup facility.

18 (3) ADDITIONAL SUPPORT AUTHORIZED.—Upon
19 request by the Director of the Federal Bureau of In-
20 vestigation, the Secretary of Defense may provide to
21 the Director such technical assistance or other re-
22 sources (including relevant threat information held
23 by the Department of Defense) as the Secretary de-
24 termines necessary to facilitate the protection of cov-

1 ered World Cup facilities from threats posed by un-
2 manned aircraft systems and unmanned aircrafts.

3 (4) COVERED FACILITY OR ASSET DEFINED.—

4 In this subsection, the term “covered facility or
5 asset” has the meaning given that term in section
6 130i(j) of title 10, United States Code.

7 (b) FEDERAL BUREAU OF INVESTIGATION AUTHORI-
8 TIES.—

9 (1) TEMPORARY AUTHORITY.—During the cov-
10 ered period, the Attorney General may exercise with
11 respect to a covered World Cup facility the authority
12 under section 210G of the Homeland Security Act of
13 2002 (6 U.S.C. 124n), to the same extent, and, ex-
14 cept as provided in paragraph (2), subject to the
15 same conditions and limitations as the Attorney
16 General may exercise such authority with respect to
17 a covered facility or asset under such section.

18 (2) TEMPORARY WAIVER OF CERTAIN PRIVACY
19 LIMITATIONS.—During the covered period, the At-
20 torney General may waive the applicability of one or
21 more regulations specified in subsection (e) of sec-
22 tion 210G of the Homeland Security Act of 2002 (6
23 U.S.C. 124n) (relating to privacy protection) to the
24 exercise of the authority under subsection (b)(1)(A)
25 of such section for the detection of an unmanned

1 aircraft system or unmanned aircraft to mitigate a
2 threat posed by such system or aircraft to the safety
3 or security of a covered World Cup facility.

4 (3) COVERED FACILITY OR ASSET DEFINED.—

5 In this subsection, the term “covered facility or
6 asset” has the meaning given that term in section
7 210G(k) of the Homeland Security Act of 2002 (6
8 U.S.C. 124n(k)).

9 (c) DEFINITIONS.—In this section:

10 (1) The terms “unmanned aircraft” and “un-
11 manned aircraft system” have the meanings given
12 those terms in section 130i(j) of title 10, United
13 States Code.

14 (2) The term “covered period” means the pe-
15 riod—

16 (A) beginning on the date that is 60 days
17 before the date on which the first FIFA World
18 Cup 2026 event is held in the United States;
19 and

20 (B) ending on the date that is 60 days
21 after the date on which the last FIFA World
22 Cup 2026 event is held in the United States.

23 (3) The term “covered World Cup facility”
24 means any stadium or other facility located in the

- 1 United States at which a FIFA World Cup 2026
- 2 event is held.
