

**AMENDMENT TO RULES COMMITTEE PRINT 118-**

**OFFERED BY MRS. LUNA OF FLORIDA**

At the end of subtitle E of title X, insert the following:

1 **SEC. 10\_\_\_. PROHIBITION ON PROMOTION OF CRITICAL**  
2 **RACE THEORY AND ASSOCIATED RACE-**  
3 **BASED THEORIES.**

4 (a) PROTECTION FROM CRITICAL RACE THEORY IN-  
5 DOCTRINATION.—No employee of the Department of De-  
6 fense or member of the Armed Forces acting in their offi-  
7 cial capacity may promote, endorse, or advocate for critical  
8 race theory or associated race-based theories described in  
9 subsection (b) or may compel or train any member of the  
10 Armed Forces or employee of the Department of Defense  
11 to believe or profess belief in such theories.

12 (b) ASSOCIATED RACE-BASED THEORIES DE-  
13 SCRIBED.—In this section, the term “associated race-  
14 based theories” includes the following principles:

15 (1) That any race, ethnicity, color, or national  
16 origin is inherently superior or inferior to any other  
17 race, ethnicity, color, or national origin.

1           (2) That the United States is a fundamentally  
2 racist country.

3           (3) That the Declaration of Independence, the  
4 Constitution of the United States, or the Federalist  
5 Papers are fundamentally racist documents.

6           (4) That an individual's moral character or  
7 worth is determined by the individual's race, eth-  
8 nicity, color, or national origin.

9           (5) That an individual, by virtue of the individ-  
10 ual's race, is inherently racist or oppressive, whether  
11 consciously or unconsciously.

12           (6) That an individual, by virtue of race, bears  
13 collective guilt and is inherently responsible for ac-  
14 tions committed in the past by other members of the  
15 individual's race, ethnicity, color, or national origin.

16           (7) That an individual, by virtue of the individ-  
17 ual's race, should be discriminated against or receive  
18 adverse treatment to achieve diversity, equity, or in-  
19 clusion.

20           (8) That an individual should feel discomfort,  
21 guilt, or any other form of psychological distress on  
22 account of the individual's race, color, or national  
23 origin.

24           (9) That virtues such as merit, excellence, hard  
25 work, fairness, neutrality, objectivity, and racial

1 colorblindness are racist or in any way discrimina-  
2 tory, or were created by members of a particular  
3 race, color, or national origin to oppress members of  
4 another race, color, or national origin.

5 (10) That to be “antiracist” requires explicitly  
6 or implicitly promoting racial discrimination to ad-  
7 vance diversity, equity, and inclusion.
