

AMENDMENT TO RULES COMMITTEE PRINT 118-

10

OFFERED BY MR. CURTIS OF UTAH

At the end of subtitle B of title X, insert the following:

1 **SEC. 10___ . REPORT ON IRANIAN INVOLVEMENT IN RE-**
2 **GIONAL NARCOTICS TRADE.**

3 (a) SENSE OF CONGRESS.—It is the sense of Con-
4 gress that the Middle East narcotics trade continues to
5 evolve, including through expanding volumes and routes
6 facilitating the sale, supply, or transfer of captagon and
7 methamphetamines throughout the region.

8 (b) REPORT.—Not later than 180 days after the date
9 of the enactment of this Act, the Secretary of Defense,
10 in coordination with the Secretary of State and the Direc-
11 tor of National Intelligence, shall submit to the congres-
12 sional defense committees, the Committee on Foreign Af-
13 fairs and the Permanent Select Committee on Intelligence
14 in the House of Representatives, and the Committee on
15 Foreign Relations and the Select Committee on Intel-
16 ligence in the Senate a report on Iranian involvement in
17 the narcotics trade in the Middle East region. Such report
18 shall include each of the following:

1 (1) An assessment of any element of the Gov-
2 ernment of Iran, including the Islamic Revolutionary
3 Guard Corps (in this section referred to as the
4 “IRGC”) and any Iran-backed group operating in
5 Iraq, Syria, Lebanon, or Yemen, that supports the
6 sale, supply, or transfer of narcotics in the Middle
7 East region.

8 (2) An assessment of the benefits accrued from
9 the sale, supply, and transfer of narcotics in the re-
10 gion by any element of the Government of Iran, in-
11 cluding the IRGC and any Iran-backed groups oper-
12 ating in Iraq, Syria, Lebanon, or Yemen.

13 (3) An assessment of all foreign terrorist orga-
14 nizations to or for which the IRGC, or any person
15 owned or controlled by the IRGC, provides material
16 support in the sale, supply, transfer, or production
17 of captagon or other related narcotics or precursors
18 in the Middle East and North Africa.

19 (4) An assessment of activities conducted by
20 the IRGC in Afghanistan related to the trade of
21 methamphetamine or opiates, including synthetic
22 opiates.

23 (5) A detailed account of intercepted transfers
24 involving the United States Fifth Fleet of narcotics
25 from Iran or involving Iranian nationals or persons

1 acting, or purporting to act, for or on behalf of the
2 Government of Iran, including the IRGC.

3 (c) FORM.—The report required under subsection (b)
4 shall be submitted in unclassified form, but may contain
5 a classified annex.
