

**AMENDMENT TO RULES COMM. PRINT 118–36**  
**OFFERED BY MR. PFLUGER OF TEXAS**

Add at the end of subtitle B of title XIII the following:

1 **SEC. 1318. DETERMINATION OF WHETHER ACTIONS OF**  
2 **CERTAIN CHINESE ENTITIES MEET CRITERIA**  
3 **FOR IMPOSITION OF SANCTIONS.**

4 (a) IN GENERAL.—Not later than 30 days after the  
5 date of the enactment of this Act, the President shall—

6 (1) determine whether any entity specified in  
7 subsection (b)—

8 (A) is responsible for or complicit in, or  
9 has directly or indirectly engaged in, serious  
10 human rights abuses against Uyghurs or other  
11 predominantly Muslim ethnic groups in the  
12 Xinjiang Uyghur Autonomous Region of the  
13 People’s Republic of China; and

14 (B) meets the criteria for the imposition of  
15 sanctions under—

16 (i) the Global Magnitsky Human  
17 Rights Accountability Act (22 U.S.C. 1010  
18 et seq.) and Executive Order 13818 (50  
19 U.S.C. 1701 note; relating to blocking the

1 property of persons involved in serious  
2 human rights abuse or corruption), as  
3 amended on or after the date of the enact-  
4 ment of this Act;

5 (ii) section 6 of the Uyghur Human  
6 Rights Policy Act of 2020 (Public Law  
7 116–145; 22 U.S.C. 6901 note);

8 (iii) Executive Order 13876 (Imposing  
9 Sanctions with Respect to Iran); or

10 (iv) Executive Order 13553 (Blocking  
11 Property of Certain Persons With Respect  
12 to Serious Human Rights Abuses By The  
13 Government of Iran and Taking Certain  
14 Other Actions); and

15 (2) submit to Congress a report on such deter-  
16 mination that includes the reasons for such deter-  
17 mination.

18 (b) ENTITIES SPECIFIED.—An entity specified in this  
19 subsection is any of the following:

20 (1) Hangzhou Hikvision Digital Technology  
21 Co., Ltd.

22 (2) Shenzhen Huada Gene Technology Co.,  
23 Ltd. (BGI Group).

24 (3) Tiandy Technologies Co., Ltd.

1           (4) Zhejiang Dahua Technology Co., Ltd. (Re-  
2           suscitate Tiandy)

3           (c) EFFECT OF POSITIVE DETERMINATION.—If the  
4           President makes a determination in the affirmative with  
5           respect to an entity specified in subsection (b), the Presi-  
6           dent shall include such entity on the list of specially des-  
7           ignated nationals and blocked persons maintained by the  
8           Office of Foreign Assets Control of the Department of the  
9           Treasury.
