## Amendment to division C of Rules Committee Print 115–71 Offered by Mrs. Lowey of New York

At the end of division C (before the short title) insert the following:

1 SEC. . (a) Amounts authorized to be appro-2 priated to carry out section 1703 of title 38, United States 3 Code, as amended by section 101 of the VA MISSION 4 Act of 2018, shall be considered changes in concepts and definitions pursuant to section 251(b)(1) of the Balanced 5 Budget and Emergency Deficit Control Act of 1985 (2) 6 U.S.C. 901(b)(1)). These changes shall be reflected only 7 8 in the budget year in each sequestration preview report 9 required by section 254(c) of such Act (2 U.S.C. 904(c)). 10 For each budget year, the baseline level of new budget 11 authority using up-to-date concepts and definitions shall be equal to the discretionary appropriations that are speci-12 fied for those authorizations of appropriations in the budg-13 14 et that the President submits under section 1105 of title 15 31, United States Code, including those already provided for that fiscal year as advance discretionary new budget 16 authority. 17

1 (b) Within 30 days of the publication of a final rule 2 in the Federal Register promulgating the regulations pur-3 suant to section 101(c) of the VA MISSION Act of 2018, 4 the Office of Management and Budget shall further adjust 5 the fiscal year 2019 discretionary spending limits to reflect the impact of those regulations, as estimated by the 6 7 Department of Veterans Affairs, on the discretionary ap-8 propriations that are specified for those authorizations of 9 appropriations in the budget that the President submitted 10 for that fiscal year under section 1105 of title 31 United States Code, and shall provide written notification to Con-11 12 gress of such further adjustments.

13 (c) Not later than 30 days after the date each year on which the President submits the budget request under 14 15 section 1105 of title 31 United States Code, and also 30 days after the publication of the final rule specified in sub-16 section (b), the Secretary of Veterans Affairs shall submit 17 to the Committees on Appropriations of both Houses of 18 19 Congress a report detailing the estimates of the resources 20 required by the Department for those authorizations of 21 appropriations, as forecast using the Enrollee Health Care 22 Projections Model, or other methodologies used by the De-23 partment.

24 (d) For each fiscal year, the Office of Management25 and Budget shall further adjust the discretionary spending

limits in section 251(c) of the Balanced Budget and Emer gency Deficit Control Act of 1985 (2 U.S.C. 901(c)) to
reflect the transmittal of any formal and informal
supplementals and amendments, as those terms are de fined in section 110 of Office of Management and Budget
Circular A-11, for those authorizations of appropriations
and shall provide written notification to Congress of such
further adjustments within 30 days of such transmittal.
