At the end of title LVIII of division E, add the following:

## 1 SEC. 58\_\_\_\_\_. RESOLUTION OF CONTROVERSIES UNDER 2 SERVICEMEMBERS CIVIL RELIEF ACT.

3 (a) IN GENERAL.—Section 102 of the 4 Servicemembers Civil Relief Act (50 U.S.C. 3912) is 5 amended by adding at the end the following new sub-6 section:

7 "(d) WRITTEN CONSENT REQUIRED FOR ARBITRA-TION.—Notwithstanding any other provision of law, when-8 9 ever a contract with a servicemember, or a servicemember and the servicemember's spouse jointly, provides for the 10 11 use of arbitration to resolve a controversy subject to a provision of this Act and arising out of or relating to such 12 13 contract, arbitration may be used to settle such controversy only if, after such controversy arises, all parties 14 15 to such controversy consent in writing to use arbitration to settle such controversy.". 16

17 (b) APPLICABILITY.—Subsection (d) of such section,18 as added by subsection (a), shall apply with respect to con-

LIMITATION ON WAIVER OF RIGHTS AND **SEC. 58** 4 **PROTECTIONS UNDER SERVICEMEMBERS** 5 **CIVIL RELIEF ACT.** 6 (a) IN GENERAL.—Section 107(a)of the 7 Servicemembers Civil Relief Act (50 U.S.C. 3918(a)) is 8 amended-9 (1) in the second sentence, by inserting "and if 10 it is made after a specific dispute has arisen and the 11 dispute is identified in the waiver" after "to which 12 it applies"; and 13 (2) in the third sentence, by inserting "and if 14 it is made after a specific dispute has arisen and the dispute is identified in the waiver" after "period of 15 16 military service". 17 (b) APPLICABILITY.—The amendment made by subsection (a) shall apply with respect to waivers made on 18 19 or after the date of the enactment of this Act. 20 SEC. 58 .
