

**AMENDMENT TO RULES COMMITTEE PRINT 119-8**  
**OFFERED BY MR. DAVIS OF NORTH CAROLINA**

At the end of subtitle D of title I, add the following  
new section:

1   **SEC. 1\_\_\_\_. MODIFICATION TO PROHIBITION ON RETIRE-**  
2                           **MENT OF F-15E AIRCRAFT.**

3           (a) IN GENERAL.—Section 9062(l) of title 10, United  
4 States Code, is amended—

5                   (1) in paragraph (1)—

6                           (A) in subparagraph (A), by striking “re-  
7           tire more than 68 F-15E aircraft” and insert-  
8           ing “retire any F-15E aircraft until—

9                                   “(i) a replacement aircraft is fielded  
10                           in sufficient numbers—

11   “(I) to maintain the total aircraft  
12   assigned at a given unit such that  
13   there is no reduction in the readiness  
14   level of such unit; and

15   “(II) to maintain the two oper-  
16   ational aircraft squadrons at Seymour  
17   Johnson Air Force Base and Moun-  
18   tain Home Air Force Base; and

1 “(ii) there is a process in place  
2 through which the Air Force Reserve and  
3 Air National Guard may accept F-15E  
4 aircraft replaced as described in clause (i)  
5 into service in such reserve component as  
6 the head of such component deems appro-  
7 priate;” and

8 (B) in subparagraph (C), by striking  
9 “(other than an aircraft identified for retire-  
10 ment under subparagraph (A))” and inserting  
11 “(other than an aircraft replaced as described  
12 in subparagraph (A)(i)))”;

13 (2) by redesignating paragraph (2) as para-  
14 graph (3); and

15 (3) by inserting after paragraph (1), the fol-  
16 lowing new paragraph:

17 “(2) Nothing in paragraph (1) shall be construed to  
18 restrict the Secretary of the Air Force from analyzing,  
19 planning, evaluating, or proposing movement of F-15E  
20 aircraft with -220 engines from Seymour Johnson Air  
21 Force Base or Mountain Home Air Force Base to a base  
22 used by the reserve components of the Air Force.”.

23 (b) REPEAL.—Section 150 of the National Defense  
24 Authorization Act for Fiscal Year 2025 (Public Law 118–  
25 159; 138 Stat. 1812) is amended—

- 1 (1) in the section heading, by striking “**PROHI-**  
2 **BITION ON RETIREMENT OF F-15E AIRCRAFT**  
3 **AND REQUIREMENT**” and inserting “**REQUIRE-**  
4 **MENT**”
- 5 (2) by striking subsection (a); and
- 6 (3) by redesignating subsections (b) and (c) as  
7 subsections (a) and (b), respectively.
