

AMENDMENT TO RULE COMMITTEE PRINT
118-10
OFFERED BY MR. DAVIDSON OF OHIO

At the end of subtitle C of title XVIII, add the following:

1 **SEC. 18___. PLAN FOR REIMBURSEMENT OF CERTAIN EX-**
2 **PENSES OF UNITED STATES PERSONS EVACU-**
3 **ATED FROM AFGHANISTAN.**

4 (a) PLAN.—Not later than 120 days after the date
5 of the enactment of this Act, the Secretary of State shall
6 submit to the appropriate congressional committees a plan
7 to reimburse any covered United States person who ex-
8 pended personal funds to evacuate American citizens, law-
9 ful permanent residents of the United States, or Afghan
10 allies from Afghanistan during the period beginning on
11 August 1, 2021, and ending on November 1, 2021.

12 (b) CONSULTATION.—In developing the plan required
13 by subsection (a), the Secretary shall consult with the fol-
14 lowing:

15 (1) The Secretary of Defense.

16 (2) Nongovernmental organizations and vet-
17 erans service organizations with expertise in sup-

1 porting the evacuation of American citizens and Af-
2 ghan allies from Afghanistan.

3 (c) ELEMENTS.—The plan required by subsection (a)
4 shall also include the following elements:

5 (1) Eligibility requirements for covered United
6 States persons to file a reimbursement claim under
7 the plan.

8 (2) The criteria for reimbursement, including
9 the types of reimbursable claims and maximum re-
10 imbursement limit.

11 (3) The process for filing a reimbursement
12 claim.

13 (4) An estimate of the time that would be asso-
14 ciated with processing a reimbursement claim.

15 (5) The supporting documentation required to
16 file a reimbursement claim.

17 (6) The process for disbursing funds to United
18 States persons once a reimbursement claim is
19 verified and approved,

20 (7) An estimate of the costs that would be asso-
21 ciated with implementing the Plan.

22 (8) A list of each nongovernmental organization
23 and each veteran service organization consulted in
24 accordance with subsection (b)(2) during the devel-
25 opment of the plan.

1 (d) DEFINITIONS.—In this section:

2 (1) The term “appropriate congressional com-
3 mittees” means the Committee on Foreign Affairs of
4 the House of Representatives and the Committee on
5 Foreign Relations of the Senate.

6 (2) The term “Afghan ally” means an indi-
7 vidual who was eligible, upon evacuation during the
8 period described in subsection (a), for—

9 (A) special immigrant status under section
10 101(a)(27) of the Immigration and Nationality
11 Act (8 U.S.C. 1101(a)(27)), pursuant to section
12 602(b) of the Afghan Allies Protection Act of
13 2009 (Public Law 111–8; 8 U.S.C. 1101 note);
14 or

15 (B) Priority 1 or Priority 2 processing
16 under the refugee resettlement priority system.

17 (3) The term “covered United States person”
18 means—

19 (A) an individual who is a citizen or na-
20 tional of the United States or an alien lawfully
21 admitted for permanent residence in the United
22 States; or

23 (B) an entity that is a nongovernmental
24 organization and organized under the laws of

1 the United States or of any jurisdiction within
2 the United States.
