

AMENDMENT TO RULES COMM. PRINT 118–36
OFFERED BY MR. DAVIDSON OF OHIO

At the end of subtitle D of title XII, add the following:

1 **SEC. 12__ . REPORT AND STRATEGY FOR UNITED STATES IN-**
2 **VOLVEMENT IN UKRAINE.**

3 (a) IN GENERAL.—Not later than 30 days after the
4 date of the enactment of this Act, the President, in coordi-
5 nation with the Secretary of Defense and the Secretary
6 of State, shall develop and submit to the appropriate con-
7 gressional committees a report that contains a strategy
8 for United States involvement in Ukraine.

9 (b) ELEMENTS.—The report required by subsection
10 (a) shall—

11 (1) define the United States national interests
12 at stake with respect to the conflict between the
13 Russian Federation and Ukraine;

14 (2) identify specific objectives the President be-
15 lieves must be achieved in Ukraine in order to pro-
16 tect the United States national interests defined in
17 paragraph (1), and for each objective—

1 (A) an estimate of the amount of time re-
2 quired to achieve the objective, with an expla-
3 nation;

4 (B) benchmarks to be used by the Presi-
5 dent to determine whether an objective has been
6 met, is in the progress of being met, or cannot
7 be met in the time estimated to be required in
8 subparagraph (A); and

9 (C) estimates of the amount of resources,
10 including United States personnel, materiel,
11 and funding, required to achieve the objective;
12 and

13 (3) list the expected contribution for security
14 assistance made by European member countries of
15 the North Atlantic Treaty Organization within the
16 next fiscal year.

17 (c) FORM.—The report required by subsection (a)
18 shall be submitted in unclassified form, but may include
19 a classified annex.

20 (d) BRIEFING.—Not later than 45 days after the date
21 of the submission of the report required by subsection (a),
22 the Secretary of Defense and the Secretary of State shall
23 provide to the appropriate congressional committees, and
24 other Members of Congress that wish to participate, a
25 briefing on the United States strategy with respect to

1 Ukraine and plans for the implementation of such strat-
2 egy.

3 (e) LIMITATION ON FUNDS.—None of the amounts
4 authorized to be appropriated or otherwise made available
5 by this Act, the National Defense Authorization Act for
6 Fiscal Year 2024, or the Ukraine Security Supplemental
7 Appropriations Act, 2024 (division B of Public Law 118–
8 50) may be made available for Ukraine until the report
9 required by subsection (a) is submitted to the appropriate
10 congressional committees and the briefing required by
11 subsection (d) is held.

12 (f) APPROPRIATE CONGRESSIONAL COMMITTEES DE-
13 FINED.—In this section, the term “appropriate congres-
14 sional committees” means—

- 15 (1) the congressional defense committees; and
16 (2) the Committee on Foreign Affairs of the
17 House of Representatives and the Committee on
18 Foreign Relations of the Senate.
