1 **SEC. \_\_\_\_.** **IMPOSITION OF INITIAL SANCTIONS.**

2 (a) **AUTOMATIC IMPOSITION OF SANCTIONS.**—As of  
3 the date of the enactment of this Act, the President shall  
4 impose the sanctions under section 3 with respect to—

5 (1) each individual specified in subsection (b);

6 and

7 (2) each individual holding, as of such date of  
8 enactment, a position described in subsection (c).
