AMENDMENT TO RULES COMM. PRINT 116-57 OFFERED BY MR. DEUTCH OF FLORIDA

Add at the end of subtitle G of title XII the following:

1	SEC. 12 COUNTERING WHITE IDENTITY TERRORISM
2	GLOBALLY.
3	(a) Strategy and Coordination.—Not later than
4	six months after the date of the enactment of this Act,
5	the Secretary of State shall—
6	(1) develop and submit to the Committee on
7	Foreign Affairs of the House of Representatives and
8	the Committee on Foreign Relations of the Senate
9	a Department of State-wide strategy entitled the
10	"Department of State Strategy for Countering
11	White Identity Terrorism Globally" (in this section
12	referred to as the "strategy"); and
13	(2) designate the Coordinator for Counterter-
14	rorism of the Department to coordinate Department
15	efforts to counter white identity terrorism globally,
16	including with United States diplomatic and con-
17	sular posts, the Director of the National Counterter-
18	rorism Center, the Director of the Central Intel-
19	ligence Agency, the Attorney General, the Director

1	of National Intelligence, the Secretary of Homeland
2	Security, the Director of the Federal Bureau of In-
3	vestigation, the Secretary of the Treasury, and the
4	heads of any other relevant Federal departments or
5	agencies.
6	(b) Elements.—The strategy shall at a minimum
7	contain the following:
8	(1) An assessment of the global threat from
9	white identity terrorism abroad, including geo-
10	graphic or country prioritization based on the as-
11	sessed threat to the United States.
12	(2) A description of the coordination mecha-
13	nisms between relevant bureaus and offices within
14	the Department of State, as well as with United
15	States diplomatic and consular posts, for developing
16	and implementing efforts to counter white identity
17	terrorism.
18	(3) A description of how the Department plans
19	to build on any existing strategy developed by the
20	Bureau for Counterterrorism to—
21	(A) adapt or expand existing Department
22	programs, projects, activities, or policy instru-
23	ments based on existing authorities for the spe-
24	cific purpose of degrading and delegitimizing

1	the white identity terrorist movement globally;
2	and
3	(B) identify the need for any new Depart-
4	ment programs, projects, activities, or policy in-
5	struments for the specific purpose of degrading
6	and delegitimizing the white identity terrorist
7	movement globally, including a description of
8	the steps and resources necessary to establish
9	any such programs, projects, activities, or policy
10	instruments, noting whether such steps would
11	require new authorities.
12	(4) Detailed plans for using public diplomacy,
13	including the efforts of the Secretary of State and
14	other senior Executive Branch officials, including
15	the President, to degrade and delegitimize white
16	identity terrorist ideologues and ideology globally, in-
17	cluding by—
18	(A) countering white identity terrorist mes-
19	saging and supporting efforts to redirect poten-
20	tial supporters away from white identity ter-
21	rorist content online;
22	(B) exposing foreign government support
23	for white identity terrorist ideologies, objectives,
24	ideologues, networks, organizations, and inter-
25	net platforms;

1	(B) engaging with foreign governments
2	and internet service providers and other rel-
3	evant technology entities, to prevent or limit
4	white identity terrorists from exploiting internet
5	platforms in furtherance of or in preparation
6	for acts of terrorism or other targeted violence,
7	as well as the recruitment, radicalization, and
8	indoctrination of new adherents to white iden-
9	tity terrorism; and
10	(C) identifying the roles and responsibil-
11	ities for the Office of the Under Secretary for
12	Public Affairs and Public Diplomacy and the
13	Global Engagement Center in developing and
14	implementing such plans.
15	(6) An outline of steps the Department is tak-
16	ing or will take in coordination, as appropriate, with
17	the Director of the National Counterterrorism Cen-
18	ter, the Director of the Central Intelligence Agency,
19	the Attorney General, the Director of National Intel-
20	ligence, the Secretary of Homeland Security, the Di-
21	rector of the Federal Bureau of Investigation, the
22	Secretary of the Treasury, and the heads of any
23	other relevant Federal departments or agencies to
24	improve information and intelligence sharing with

1	other countries on white identity terrorism based on
2	existing authorities by—
3	(A) describing plans for adapting or ex-
4	panding existing mechanisms for sharing infor-
5	mation, intelligence, or counterterrorism best
6	practices, including facilitating the sharing of
7	information, intelligence, or counterterrorism
8	best practices gathered by Federal, State, and
9	local law enforcement; and
10	(B) proposing new mechanisms or forums
11	that might enable expanded sharing of informa-
12	tion, intelligence, or counterterrorism best prac-
13	tices.
14	(7) An outline of how the Department plans to
15	use designation as a Specially Designated Global
16	Terrorist (under Executive Order 13224 (50 U.S.C.
17	1701 note)) and foreign terrorist organization (pur-
18	suant to section 219 of the Immigration and Nation-
19	ality Act (8 U.S.C. 1189)) to support the strategy,
20	including—
21	(A) an assessment and explanation of the
22	utility of applying or not applying such designa-
23	tions when individuals or entities satisfy the cri-
24	teria for such designations; and

1	(B) a description of possible remedies if
2	such criteria are insufficient to enable designa-
3	tion of any individuals or entities the Secretary
4	of State considers a potential terrorist threat to
5	the United States.
6	(8) A description of the Department's plans, in
7	consultation with the Department of the Treasury,
8	to work with foreign governments, financial institu-
9	tions, and other related entities to counter the fi-
10	nancing of white identity terrorists within the pa-
11	rameters of current law, or if no such plans exist,
12	a description of why.
13	(9) A description of how the Department plans
14	to implement the strategy in conjunction with ongo-
15	ing efforts to counter the Islamic State, al-Qaeda,
16	and other terrorist threats to the United States.
17	(10) A description of how the Department will
18	integrate into the strategy lessons learned in the on-
19	going efforts to counter the Islamic State, al-Qaeda,
20	and other terrorist threats to the United States.
21	(11) A identification of any additional resources
22	or staff needed to implement the strategy.
23	(c) Interagency Coordination.—The Secretary of
24	State shall develop the strategy in coordination with the
25	Director of the National Counterterrorism Center and in

- 1 consultation with the Director of the Central Intelligence
- 2 Agency, the Attorney General, the Director of National
- 3 Intelligence, the Secretary of Homeland Security, the Di-
- 4 rector of the Federal Bureau of Investigation, the Sec-
- 5 retary of the Treasury, and the heads of any other rel-
- 6 evant Federal departments or agencies.
- 7 (d) Stakeholder Inclusion.—The strategy shall
- 8 be developed in consultation with representatives of
- 9 United States and international civil society and academic
- 10 entities with experience researching or implementing pro-
- 11 grams to counter white identity terrorism.
- 12 (e) FORM.—The strategy shall be submitted in un-
- 13 classified form that can be made available to the public,
- 14 but may include a classified annex if the Secretary of
- 15 State determines such is appropriate.
- 16 (f) Implementation.—Not later than three months
- 17 after the submission of the strategy, the Secretary of State
- 18 shall begin implementing the strategy.
- 19 (g) Consultation.—Not later than 90 days after
- 20 the date of the enactment of this Act and not less often
- 21 than annually thereafter, the Secretary of State shall con-
- 22 sult with the Committee on Foreign Affairs of the House
- 23 of Representatives and the Committee on Foreign Rela-
- 24 tions of the Senate regarding the development and imple-
- 25 mentation of the strategy.

1	(h) Country Reports on Terrorism.—The Sec-
2	retary of State shall incorporate all credible information
3	about white identity terrorism, including regarding rel-
4	evant attacks, the identification of perpetrators and vic-
5	tims of such attacks, the size and identification of organi-
6	zations and networks, and the identification of notable
7	ideologues, in the annual country reports on terrorism
8	submitted pursuant to section 140 of the Foreign Rela-
9	tions Authorization Act, Fiscal Years 1988 and 1989 (22
10	U.S.C. 2656f).
11	(i) Report on Sanctions.—
12	(1) In general.—Not later than 120 days and
13	again 240 days after the submission of each annual
14	country report on terrorism submitted pursuant to
15	section 140 of the Foreign Relations Authorization
16	Act, Fiscal Years 1988 and 1989 (22 U.S.C. 2656f),
17	as modified in accordance with subsection (h), the
18	President shall submit to the Committee on Foreign
19	Affairs of the House of Representatives and the
20	Committee on Foreign Relations of the Senate a re-
21	port that determines whether the foreign persons,
22	organizations, and networks identified in such an-
23	nual country reports on terrorism as so modified,
24	satisfy the criteria to be designated as—

1	(A) foreign terrorist organizations under
2	section 219 of the Immigration and Nationality
3	Act (8 U.S.C. 1189); or
4	(B) Specially Designated Global Terrorist
5	under Executive Order 13224 (50 U.S.C. 1701
6	note).
7	(2) FORM.—Each determination required under
8	subsection (a) shall be submitted in unclassified
9	form, but may include a classified annex, if appro-
10	priate.
11	(j) Requirement for Independent Study to
12	MAP THE GLOBAL WHITE IDENTITY TERRORISM MOVE-
13	MENT.—
14	(1) In general.—Not later than 60 days after
15	the date of the enactment of this Act, the Secretary
16	of State shall enter into a contract with a federally
17	funded research and development center with appro-
18	priate expertise and analytical capability to carry out
19	the study described in paragraph (2).
20	(2) Study.—The study described in this sub-
21	section shall provide for a comprehensive social net-
22	work analysis of the global white identity terrorism
23	movement to—
24	(A) identify key actors, organizations, and
25	supporting infrastructure; and

1	(B) map the relationships and interactions
2	between such actors, organizations, and sup-
3	porting infrastructure.
4	(3) Report.—
5	(A) TO THE SECRETARY.—Not later than
6	one year after the date on which the Secretary
7	of State enters into a contract pursuant to sub-
8	section (a), the federally funded research and
9	development center referred to in such sub-
10	section that has entered into such contract with
11	the Secretary shall submit to the Secretary a
12	report containing the results of the study re-
13	quired under this section.
14	(B) To congress.—Not later than 30
15	days after receipt of the report under subpara-
16	graph (A), the Secretary of State shall submit
17	to the Committee of Foreign Affairs of the
18	House of Representatives and the Committee
19	on Foreign Relations of the Senate such report
20	together with any additional views or rec-
21	ommendations of the Secretary.
