19	of this Act and annually thereafter, the Secretary of Agri-
20	culture and the Comptroller General of the United States
21	shall each—
22	(1) conduct an analysis of foreign influence in
23	the United States agriculture industry; and
24	(2) submit to Congress a report that includes a
25	summary of—

1	(A) foreign investments in the United
2	States agriculture industry;
3	(B) the potential for foreign investment to
4	undermine United States agriculture production
5	and agricultural supply chains;
6	(C) the largest international threats for in-
7	creased foreign control of, and investment in
8	the United States agriculture sector; and
9	(D) agriculture-related espionage and theft
10	techniques used by foreign governments, includ-
11	ing any attempts to target United States agri-
12	cultural intellectual property, innovation, re-
13	search and development, cost or pricing data, or
14	internal strategy documents.
