OFFERED BY MR. FITZGERALD OF WISCONSIN

Add at the end of subtitle E of title VIII the following new section:

1 **SEC. 8 ____ . ACCESS TO CONTRACT BUNDLING DATA.**

2 Section 15(p) of the Small Business Act (15 U.S.C.
3 644(p)) is amended—

4 (1) by amending paragraph (1) to read as fol-
5 lows:

6 “(1) **DEFINITIONS.**—In this subsection:

7 “(A) **BUNDLED CONTRACT.**—The term
8 ‘bundled contract’ has the meaning given such
9 term in section 3(o) of the Small Business Act
10 (15 U.S.C. 632(o)).

11 “(B) **CONSOLIDATED CONTRACT.**—The
12 term ‘consolidated contract’ means a contract
13 resulting from the consolidation of contracting
14 requirements (as defined in section 44(a) of the
15 Small Business Act (15 U.S.C. 657q(a))).”;

16 (2) in paragraph (4)—

17 (A) in the heading, by inserting “AND CON-
18 SOLIDATION” after “BUNDLING”;

1 (B) in subparagraph (A), by inserting
2 “and consolidation” after “contract bundling”;
3 and

4 (C) in subparagraph (B)—

5 (i) in clause (i), by inserting “or con-
6 solidated” after “of bundled”; and

7 (ii) in clause (ii)—

8 (I) in the matter preceding sub-
9 clause (I), by inserting “or consoli-
10 dated” after “previously bundled”;

11 (II) in subclause (I), by inserting
12 “or consolidated” after “were bun-
13 dled”; and

14 (III) in subclause (II)—

15 (aa) by inserting “or consoli-
16 dated” after “to each bundled”;

17 (bb) in item (aa), by insert-
18 ing “or consolidation” after “the
19 bundling”;

20 (cc) in item (bb), by insert-
21 ing “or consolidating” after “by
22 bundling”;

23 (dd) in item (cc), by insert-
24 ing “or consolidated” after “the
25 bundled”;

1 (ee) in item (dd), by insert-
2 ing “or consolidating” after “the
3 bundling”; and
4 (ff) in item (ee)—
5 (AA) by inserting “or
6 consolidating” after “the
7 bundling”; and
8 (BB) by inserting
9 “bundled or” after “as
10 prime contractors for the”;
11 and
12 (3) in paragraph (5)(B), by striking “provide,
13 upon request” and all that follows and inserting the
14 following: “provide to the Administration procure-
15 ment information referred to in this subsection for
16 the contracting agency, including the data and infor-
17 mation described in paragraph (2) and the informa-
18 tion described in paragraph (4).”.
