13 (A) For Medicare, this budget rejects pro-14 posals to end the Medicare guarantee and shift 15 rising health care costs onto seniors by replac-16 ing Medicare with vouchers or premium support 17 for the purchase of private insurance. Such pro-18 posals will expose seniors and persons with dis-19 abilities on fixed incomes to unacceptable finan-20 cial risks, and they will weaken the traditional 21 Medicare program. Instead, this budget builds 22 on the success of the Affordable Care Act, 23 which made significant strides in health-care 24 cost containment and put into place a frame-25 work for continuous innovation. This budget

supports comprehensive reforms to give physi-1 2 cians and other care providers incentives to pro-3 vide high-quality, coordinated, efficient care, in a manner consistent with the goals of fiscal sus-4 tainability.
