At the end of title III of division A, add the following:

1	SEC. 303. FORESTRY EDUCATION AND WORKFORCE DEVEL-
2	OPMENT GRANT PROGRAM.
3	(a) In General.—The Secretary of Agriculture shall
4	establish a competitive grant program to make grants to
5	eligible institutions to carry out forestry education and
6	workforce development programs to prepare students for
7	careers in forestry.
8	(b) Proposal.—To be eligible to receive a grant
9	under this section, an eligible institution shall submit to
10	the Secretary of Agriculture a proposal at such time, in
11	such manner, and containing such information as the Sec-
12	retary may require.
13	(c) Equitable Awards.—For each fiscal year for
14	which grants are awarded under this section, the amount
15	of grant funds awarded to eligible institutions described
16	in paragraph (1) of subsection (f) shall be equal to the

1	(d) Use of Grant Funds.—
2	(1) IN GENERAL.—Grants made under this sec-
3	tion shall be used to—
4	(A) award scholarships to students enrolled
5	in the eligible institution and pursuing degrees
6	in forestry, including students historically
7	underrepresented in the field of forestry;
8	(B) expand, enhance, or improve forestry
9	educational capacities of the eligible institution,
10	including libraries, curriculum, faculty, and sci-
11	entific instrumentation;
12	(C) recruit and retain—
13	(i) secondary school or undergraduate
14	students to pursue certifications in forestry
15	or acquire training in technical forestry
16	skills, including students historically

12	(e) Payment of Non-Federal Share.—As a con-
13	dition of receiving a grant under this section, the Sec-

17	retary and based on assessed institutional needs.
18	(f) Eligible Institution Defined.—In this sec-
19	tion, the term "eligible institution" means—
20	(1) a land grant college or university, including
21	an institution eligible to receive funding under—

23	(B) the Act of August 30, 1890, including
24	Tuskegee University;

1	(C) Public Law 87–788 (commonly known

16	SEC. 304. CIVILIAN CONSERVATION CENTERS REFOREST-
17	ATION ACTIVITIES.
18	Section 147(d) of the Workforce Innovation and Op-
19	portunity Act (29 U.S.C. 3197(d)) is amended by adding
20	at the end the following:
21	"(4) Reforestation activities.—Enrollees
22	in Civilian Conservation Centers may provide assist-
23	ance in carrying out reforestation activities in pri-
