

**AMENDMENT TO RULES COMM. PRINT 116-19**

Add at the end of subtitle G of title XII the following:

**1 SEC. 1268. STRATEGY TO IMPROVE THE EFFORTS OF THE**  
**2 NIGERIAN MILITARY TO PREVENT, MITIGATE,**  
**3 AND RESPOND TO CIVILIAN HARM.**

**4 (a) STRATEGY.—**

**5 (1) REPORT.—**Not later than 180 days after  
**6** the date of the enactment of this Act, the President  
**7** shall transmit to the appropriate congressional com-  
**8** mittees a report that contains a plan for assisting  
**9** the Nigerian military to improve its efforts to pre-  
**10** vent, mitigate, and respond to civilian harm arising  
**11** from its military presence and operations.

**12 (2) UPDATES.—** Not later than one year after  
**13** the transmission of the report required under para-  
**14** graph (1) and annually thereafter, the President  
**15** shall provide to the appropriate congressional com-  
**16** mittees an update on progress made with respect to  
**17** the plan contained in such report.

**18 (b) MATTERS TO BE INCLUDED.—**The report re-  
**19** quired by subsection (a)(1) shall include the following:

1           (1) Any steps being taken by the United States  
2           Government to ensure that the Nigerian Air Force  
3           is able to prevent and minimize civilian harm in the  
4           operation of 12 A-29 Super Tucano aircraft and as-  
5           sociated weapons acquired from the United States,  
6           including training planned or provided on air-to-  
7           ground integration measures specifically intended to  
8           minimize civilian harm.

9           (2) Whether the training described in para-  
10          graph (1) is provided by United States Government  
11          or contract personnel.

12          (3) An assessment of the effectiveness of such  
13          training or other assistance in preventing civilian  
14          casualties from ground and air operations.

15          (4) An assessment of efforts by the Government  
16          of Nigeria to improve civilian protection, account-  
17          ability for human rights violations, and transparency  
18          in the defense institutions and security sector force,  
19          including the status of any national protection of ci-  
20          vilians policies, and a description of the key United  
21          States diplomatic and military efforts available to  
22          promote progress relating to such matters.

23          (5) Any other matters the President considers  
24          appropriate.

1           (c) FORM.—The report required under subsection  
2 (a)(1) shall be submitted in unclassified form, but may  
3 include a classified annex.

4           (d) APPROPRIATE CONGRESSIONAL COMMITTEES  
5 DEFINED.—In this section, the term “appropriate con-  
6 gressional committees” means—

- 7                   (1) the Committee on Armed Services and the  
8                   Committee on Foreign Relations, the Committee on  
9                   Appropriations of the Senate; and  
10                   (2) the Committee on Armed Services, the  
11                   Committee on Foreign Affairs, and the Committee  
12                   on Appropriations of the House of Representatives.
