At the end of title LV of division E, insert the following:

I	SEC. 5505. BERRYESSA SNOW MOUNTAIN NATIONAL MONU-
2	MENT EXPANSION.
3	(a) DEFINITIONS.—In this section:
4	(1) Board.—The term "Board" means the
5	Board on Geographic Names established by section
6	2 of the Act of July 25, 1947 (61 Stat. 456, chapter
7	330; 43 U.S.C. 364a).
8	(2) MAP.—The term "Map" means the map en-
9	titled "Proposed Walker Ridge (Molok Luyuk) Addi-
10	tion Berryessa Snow Mountain National Monument"
11	and dated October 26, 2021.
12	(3) Molok Luyuk.—The term "Molok Luyuk"
13	means Condor Ridge (in the Patwin language).
14	(4) National monument.—The term "Na-
15	tional Monument" means the Berryessa Snow Moun-
16	tain National Monument established by Presidential
17	Proclamation 9298, dated July 10, 2015 (80 Fed.
18	Reg. 41975), including all land, interests in the

1	land, and objects on the land identified in that Pres-
2	idential Proclamation.
3	(5) Secretary.—The term "Secretary" means
4	the Secretary of the Interior.
5	(6) Walker Ridge (molok luyuk) addi-
6	TION.—The term "Walker Ridge (Molok Luyuk) Ad-
7	dition" means the approximately 3,925 acres of Fed-
8	eral land (including any interests in, or objects on
9	the land) administered by the Bureau of Land Man-
10	agement in Lake County, California, and identified
11	as "Proposed Walker Ridge (Molok Luyuk) Addi-
12	tion" on the Map.
13	(b) NATIONAL MONUMENT EXPANSION.—
14	(1) BOUNDARY MODIFICATION.—The boundary
15	of the National Monument is modified to include the
16	Walker Ridge (Molok Luyuk) Addition.
17	(2) Map.—
18	(A) Corrections.—The Secretary may
19	make clerical and typographical corrections to
20	the Map.
21	(B) Public availability; effect.—The
22	Map and any corrections to the Map under sub-
23	paragraph (A) shall—
24	(i) be publicly available on the website
25	of the Bureau of Land Management; and

1	(ii) have the same force and effect as
2	if included in this section.
3	(3) Administration.—Subject to valid existing
4	rights, the Secretary shall administer the Walker
5	Ridge (Molok Luyuk) Addition—
6	(A) as part of the National Monument;
7	(B) in accordance with Presidential Procla-
8	mation 9298, dated July 10, 2015 (80 Fed.
9	Reg. 41975); and
10	(C) in accordance with applicable laws (in-
11	cluding regulations).
12	(c) Management Plan.—
13	(1) IN GENERAL.—Not later than 1 year after
14	the date of the enactment of this section, the Sec-
15	retary and the Secretary of Agriculture shall jointly
16	develop a comprehensive management plan for the
17	National Monument in accordance with, and in a
18	manner that fulfills the purposes described in, Presi-
19	dential Proclamation 9298, dated July 10, 2015 (80
20	Fed. Reg. 41975).
21	(2) Tribal consultation.—The Secretary
22	and the Secretary of Agriculture shall consult with
23	affected federally recognized Indian Tribes in—
24	(A) the development of the management
25	plan under paragraph (1); and

1	(B) making management decisions relating
2	to the National Monument.
3	(3) Continued engagement with indian
4	TRIBES.—The management plan developed under
5	paragraph (1) shall set forth parameters for contin-
6	ued meaningful engagement with affected federally
7	recognized Indian Tribes in the implementation of
8	the management plan.
9	(4) Effect.—Nothing in this section affects
10	the conduct of fire mitigation or suppression activi-
11	ties at the National Monument, including through
12	the use of existing agreements.
13	(d) Agreements and Partnerships.—To the
14	maximum extent practicable and in accordance with appli-
15	cable laws, on request of an affected federally recognized
16	Indian Tribe, the Secretary (acting through the Director
17	of the Bureau of Land Management) and the Secretary
18	of Agriculture (acting through the Chief of the Forest
19	Service) shall enter into agreements, contracts, and other
20	cooperative and collaborative partnerships with the feder-
21	ally recognized Indian Tribe regarding management of the
22	National Monument under relevant Federal authority, in-
23	cluding—
24	(1) the Indian Self-Determination and Edu-
25	cation Assistance Act (25 U.S.C. 5301 et seq.);

1	(2) the Federal Land Policy and Management
2	Act of 1976 (43 U.S.C. 1701 et seq.);
3	(3) the Tribal Self-Governance Act of 1994 (25
4	U.S.C. 5361 et seq.);
5	(4) the Tribal Forest Protection Act of 2004
6	(25 U.S.C. 3115a et seq.);
7	(5) the good neighbor authority under section
8	8206 of the Agricultural Act of 2014 (16 U.S.C.
9	2113a);
10	(6) Executive Order 13175 (25 U.S.C. 5301
11	note; relating to consultation and coordination with
12	Indian Tribal governments);
13	(7) Secretarial Order 3342, issued by the Sec-
14	retary on October 21, 2016 (relating to identifying
15	opportunities for cooperative and collaborative part-
16	nerships with federally recognized Indian Tribes in
17	the management of Federal lands and resources);
18	and
19	(8) Joint Secretarial Order 3403, issued by the
20	Secretary and the Secretary of Agriculture on No-
21	vember 15, 2021 (relating to fulfilling the trust re-
22	sponsibility to Indian Tribes in the stewardship of
23	Federal lands and waters).

1	(e) Designation of Condor Ridge (Molok
2	LUYUK) IN LAKE AND COLUSA COUNTIES, CALI-
3	FORNIA.—
4	(1) IN GENERAL.—The parcel of Federal land
5	administered by the Bureau of Land Management
6	located in Lake and Colusa Counties in the State of
7	California and commonly referred to as "Walker
8	Ridge" shall be known and designated as "Condor
9	Ridge (Molok Luyuk)".
10	(2) References.—Any reference in a law,
11	map, regulation, document, paper, or other record of
12	the United States to the parcel of Federal land de-
13	scribed in paragraph (1) shall be deemed to be a ref-
14	erence to "Condor Ridge (Molok Luyuk)".
15	(3) Map and legal description.—
16	(A) Preparation.—
17	(i) Initial Map.—The Board shall
18	prepare a map and legal description of the
19	parcel of Federal land designated by sub-
20	section (a).
21	(ii) Corrections.—The Board and
22	the Director of the Bureau of Land Man-
23	agement may make clerical and typo-
24	graphical corrections to the map and legal
25	description prepared under clause (i).

1	(B) Consultation.—In preparing the
2	map and legal description under subparagraph
3	(A)(i), the Board shall consult with—
4	(i) the Director of the Bureau of
5	Land Management; and
6	(ii) affected federally recognized In-
7	dian Tribes.
8	(C) Public availability; effect.—The
9	map and legal description prepared under sub-
10	paragraph (A)(i) and any correction to the map
11	or legal description made under subparagraph
12	(A)(ii) shall—
13	(i) be publicly available on the website
14	of the Board, the Bureau of Land Manage-
15	ment, or both; and
16	(ii) have the same force and effect as
17	if included in this section.
